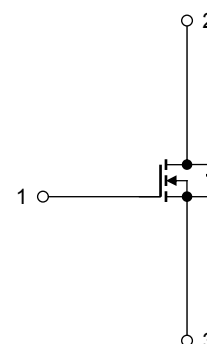

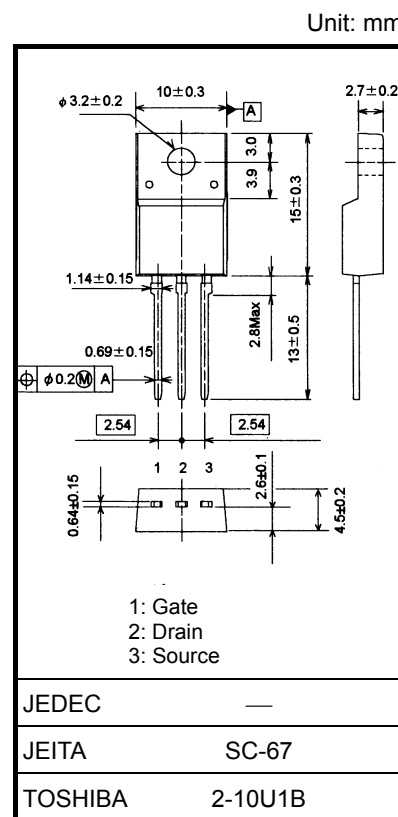

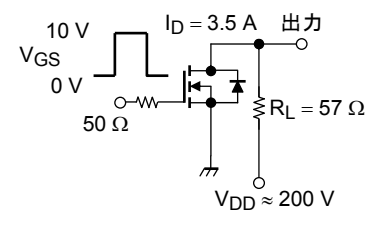
Internal Connection
