




Fig. 6.2.1 Switching Time Test Circuit







Fig. 8.11 Capacitance - V_{DS}

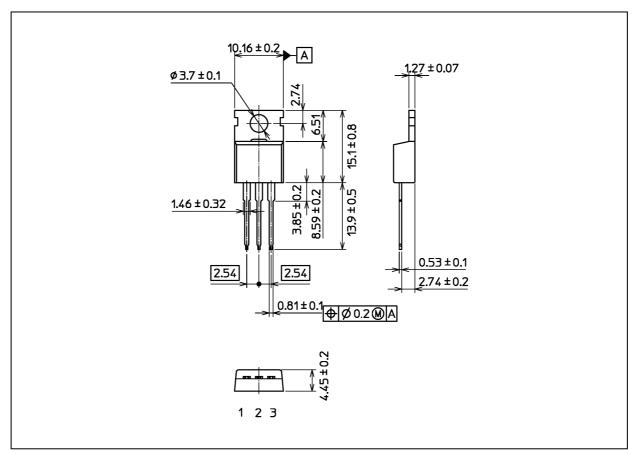
