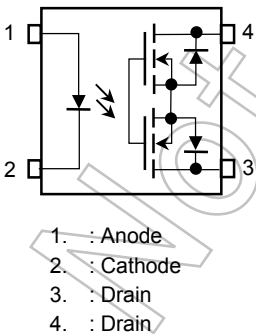

The TLP176A is suitable for replacement of mechanical relays in many applications which require space savings.

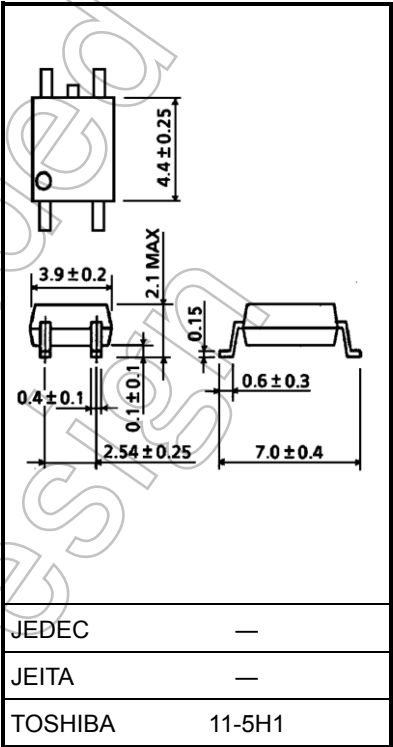
