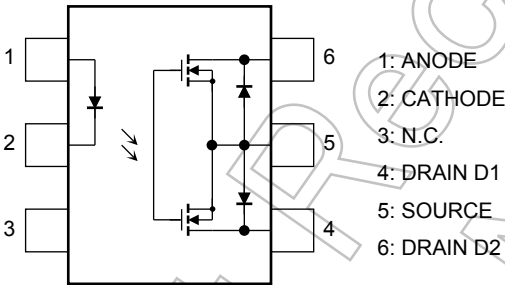

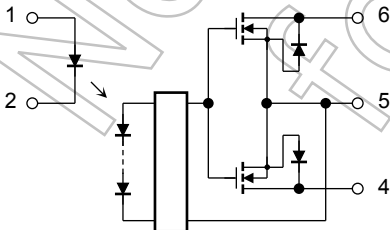
The TLP197GA is suitable for replacement of mechanical relays in many applications which require space savings.

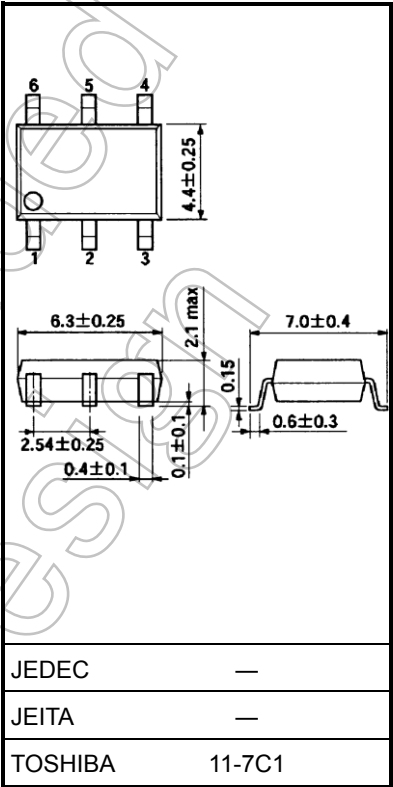
Pin Configuration (top view)
