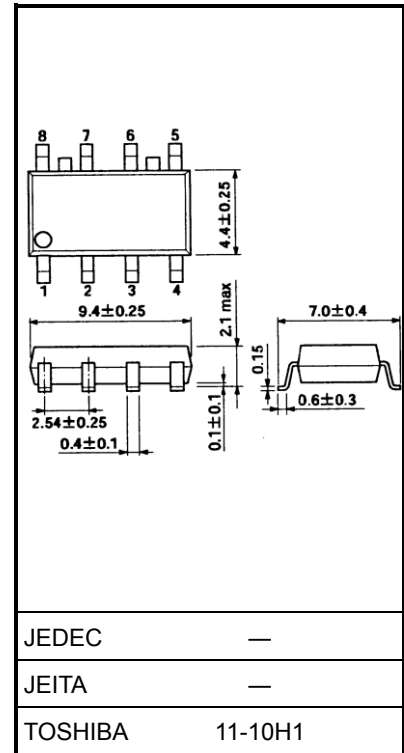

The TLP206GA is a 2-Form-A switch, which is suitable for replacement of mechanical relays in many applications.

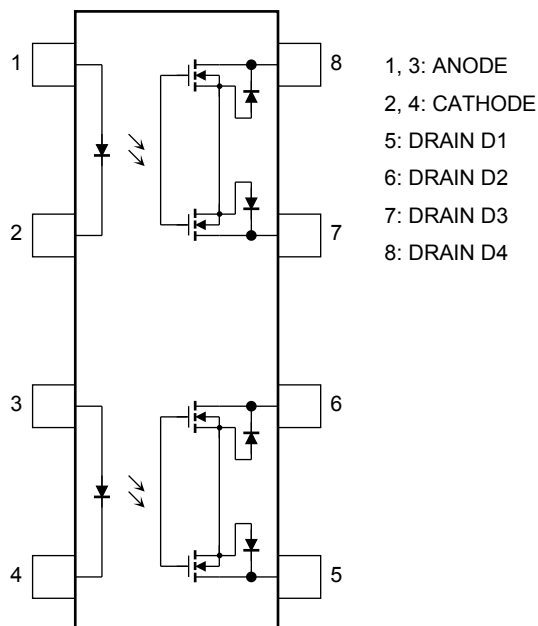
