The TOSHIBA TLP3215 is an ultra-small photorelay suitable for surfacemount assembly. The TLP3215 consists of an infrared emitting diode optically coupled to a photo-MOSFET and is housed in a 4-pin package. The TLP3215 features low CR product and extremely low On-state resistance, allowing high On-state current.

Its features also include low Off-state current and low output pin capacitance, enabling it to be used for high-frequency measuring instrument applications.




Pin Configuration (Top View)







Note 2: SWITCHING TIME TEST CIRCUIT






