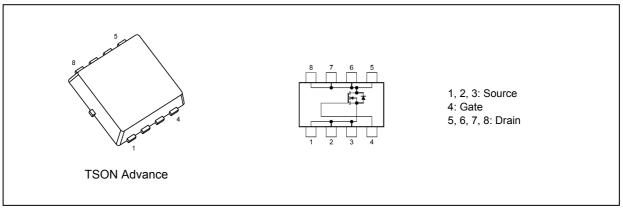




Fig. 5.1 Device Mounted on a Glass-Epoxy Board (a)




Fig. 5.2 Device Mounted on a Glass-Epoxy Board (b)








8. Characteristics Curves (Note)

Gate-source voltage V_{GS}








Fig. 8.14 Safe Operating Area (Guaranteed Maximum)

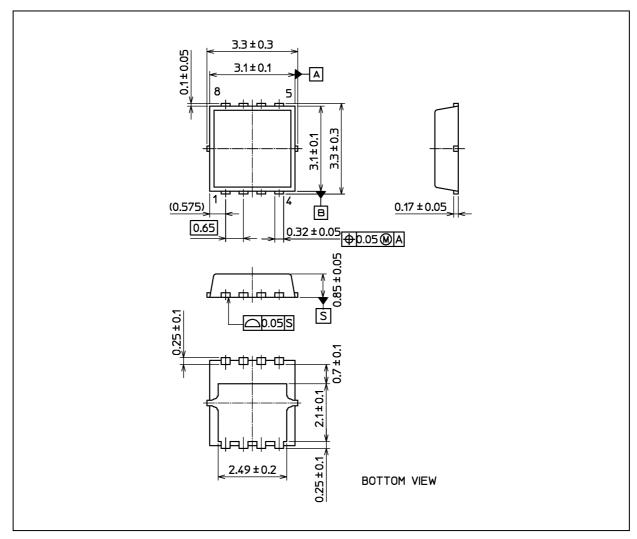
