

2. Features

- (1) Chip design of 3rd generation (Built-in SiC schottky barrier diode)
- (2) Low diode forward voltage: $V_{DSF} = -1.35 \text{ V (typ.)}$
- (3) High voltage: $V_{DSS} = 650 \text{ V}$
- (4) Low drain-source on-resistance: $R_{DS(ON)} = 107 \text{ m}\Omega$ (typ.)
- (5) Less susceptible to malfunction due to high threshold voltage: $V_{th} = 3.0$ to 5.0 V ($V_{DS} = 10$ V, $I_D = 1.2$ mA)




Fig. 6.2.1 Switching Time Test Circuit




Fig. 6.2.2 Timing Diagrams




Fig. 7.1 Marking




Fig. 8.1 I_D - V_{DS}




Fig. 8.3 I_D - V_{GS}




Fig. 8.5 $R_{DS(ON)}$ - I_D




Fig. 8.2 I_D - V_{DS}




Fig. 8.4 V_{th} - T_a




Fig. 8.6 R_{DS(ON)} - I_D






Fig. 8.7 R_{DS(ON)} - T_a




Fig. 8.9 IDR - VDS




Fig. 8.11 V_{(BR)DSS} - T_a




Fig. 8.8 R_{DS(ON)} - V_{GS}




Fig. 8.10 I_{DR} - V_{DS}




Fig. 8.12 Dynamic Input Characteristics






Fig. 8.13 C - V_{DS}




Fig. 8.14 E_{oss} - V_{DS}




Fig. 8.15 E - I_D




Fig. 8.16 E - R_G





Fig. 8.17 $r_{th(ch-c)} - t_w$ (Guaranteed Maximum)




Fig. 8.18 Safe Operating Area (Guaranteed Maximum)


Fig. 8.19 P_D - T_c (Guaranteed Maximum)
