




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking




Fig. 8.1 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.3 V<sub>DS</sub> - V<sub>GS</sub>




Fig. 8.5 V<sub>DS</sub> - V<sub>GS</sub>




Fig. 8.2 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.4 VDS - VGS




Fig. 8.6 V<sub>DS</sub> - V<sub>GS</sub>






Fig. 8.7 ID - VGS




Fig. 8.9 R<sub>DS(ON)</sub> - T<sub>a</sub>




Fig. 8.11 V<sub>(BR)DSS</sub> - T<sub>a</sub>




Fig. 8.8  $R_{DS(ON)}$  -  $I_D$ 




Fig. 8.10 IDR - VDS




Fig. 8.12 V<sub>th</sub> - T<sub>a</sub>






Fig. 8.13 Capacitance - V<sub>DS</sub>




Fig. 8.15 E<sub>AS</sub> - T<sub>ch</sub>(Guaranteed Maximum)




Fig. 8.14 Dynamic Input/Output Characteristics




Fig. 8.16 Test Circuit/Waveform






Fig. 8.17  $z_{th(ch-c)}$  -  $t_w$  (Guaranteed Maximum)




Fig. 8.18 Safe Operating Area (Guaranteed Maximum)





Fig. 8.19 P<sub>D</sub> - T<sub>c</sub> (Guaranteed Maximum)
