


Fig. 1 - Power Dissipation Limit vs. Ambient Temperature




Fig. 2 - Forward Current Limit vs. Ambient Temperature




Fig. 3 - Forward Current vs. Forward Voltage




Fig. 4 - Relative Forward Voltage vs. Ambient Temperature




Fig. 5 - Radiant Intensity vs. Forward Current




Fig. 6 - Relative Radiant Intensity vs. Ambient Temperature




Fig. 7 - Relative Radiant Intensity vs. Wavelength





Fig. 8 - Relative Radiant Intensity vs. Angular Displacement



DRYPACK

Devices are packed in moisture barrier bags (MBB) to prevent the products from moisture absorption during transportation and storage. Each bag contains a desiccant.

FLOOR LIFE

Floor life (time between soldering and removing from MBB) must not exceed the time indicated on MBB label:

Floor life: 168 h

Conditions: T_{amb} < 30 °C, RH < 60 %

Moisture sensitivity level 3, according to J-STD-020.

DRYING

In case of moisture absorption devices should be baked before soldering. Conditions see J-STD-020 or label. Devices taped on reel dry using recommended conditions 192 h at 40 $^{\circ}$ C (+ 5 $^{\circ}$ C), RH < 5 $^{\circ}$ K.

TAPE AND REEL

PLCC-2 components are packed in antistatic blister tape (DIN IEC (CO) 564) for automatic component insertion. Cavities of blister tape are covered with adhesive tape.




Fig. 10 - Blister Tape




Fig. 11 - Tape Dimensions in mm for PLCC-2

MISSING DEVICES

A maximum of 0.5~% of the total number of components per reel may be missing, exclusively missing components at the beginning and at the end of the reel. A maximum of three consecutive components may be missing, provided this gap

is followed by six consecutive components.




Fig. 12 - Beginning and End of Reel

The tape leader is at least 160 mm and is followed by a carrier tape leader with at least 40 empty compartments. The tape leader may include the carrier tape as long as the cover tape is not connected to the carrier tape. The least component is followed by a carrier tape trailer with a least 75 empty compartments and sealed with cover tape.




Fig. 13 - Dimensions of Reel-GS08




Fig. 14 - Dimensions of Reel-GS18
