



Fig. 1 - Test Circuit, Non-Saturated Operation




Fig. 2 - Test Circuit, Saturated Operation




Fig. 4 - Total Power Dissipation vs. Ambient Temperature




Fig. 5 - Forward Voltage vs. Forward Current




Fig. 6 - Collector Current vs. Collector Emitter Voltage




Fig. 7 - Leakage Current vs. Ambient Temperature




Fig. 8 - Collector Current vs. Collector Emitter Voltage




Fig. 9 - Normalized Current Transfer Ratio (non-saturated) vs. Ambient Temperature




Fig. 10 - Normalized Current Transfer Ratio (saturated) vs. Ambient Temperature




Fig. 11 - Collector Emitter Voltage vs. Ambient Temperature




Fig. 12 - Normalized CTR (non-saturated) vs. Forward Current




Fig. 13 - Normalized CTR (saturated) vs. Forward Current




Fig. 14 - F<sub>CTR</sub> vs. Phase Angle




Fig. 15 - F<sub>CTR</sub> vs. Collector Current






Fig. 16 - Switching Time vs. Load Resistance




Fig. 17 - Tape and Reel Shipping Medium






Fig. 18 - Tape and Reel Packing (3000 parts per reel)
