






On-Resistance vs. Drain Current








Gate Charge




Source Drain Diode Forward Voltage




On-Resistance vs. Junction Temperature



Drain-Source Breakdown vs. Junction Temperature






Safe Operating Area



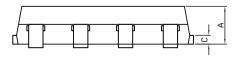

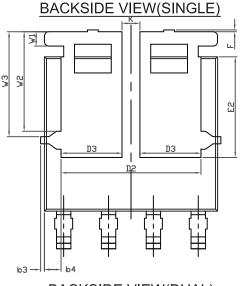
