


## **Total Power Dissipation vs. Ambient Temperature:**




## **Collector Dark Current vs. Ambient Temperature:**







### **Relative CTR vs. Ambient Temperature:**





#### **Collector-Emitter Saturation Voltage vs. Ambient Temperature:**







## **Forward Current vs. Forward Voltage:**



### **Collector Current vs. Collector-Emitter Voltage:**







## **Switching time vs. Load Resistance:**






## **Gain vs. Frequency:**








#### Soldering:

- The soldering pad pattern shown above is a general recommendation for the easy assembly of optoelectronic components. If a high
  degree of precision is required for the selected application (i.e. high density assembly), the customer must ensure that the soldering pad

#### **Cleaning and Washing:**






