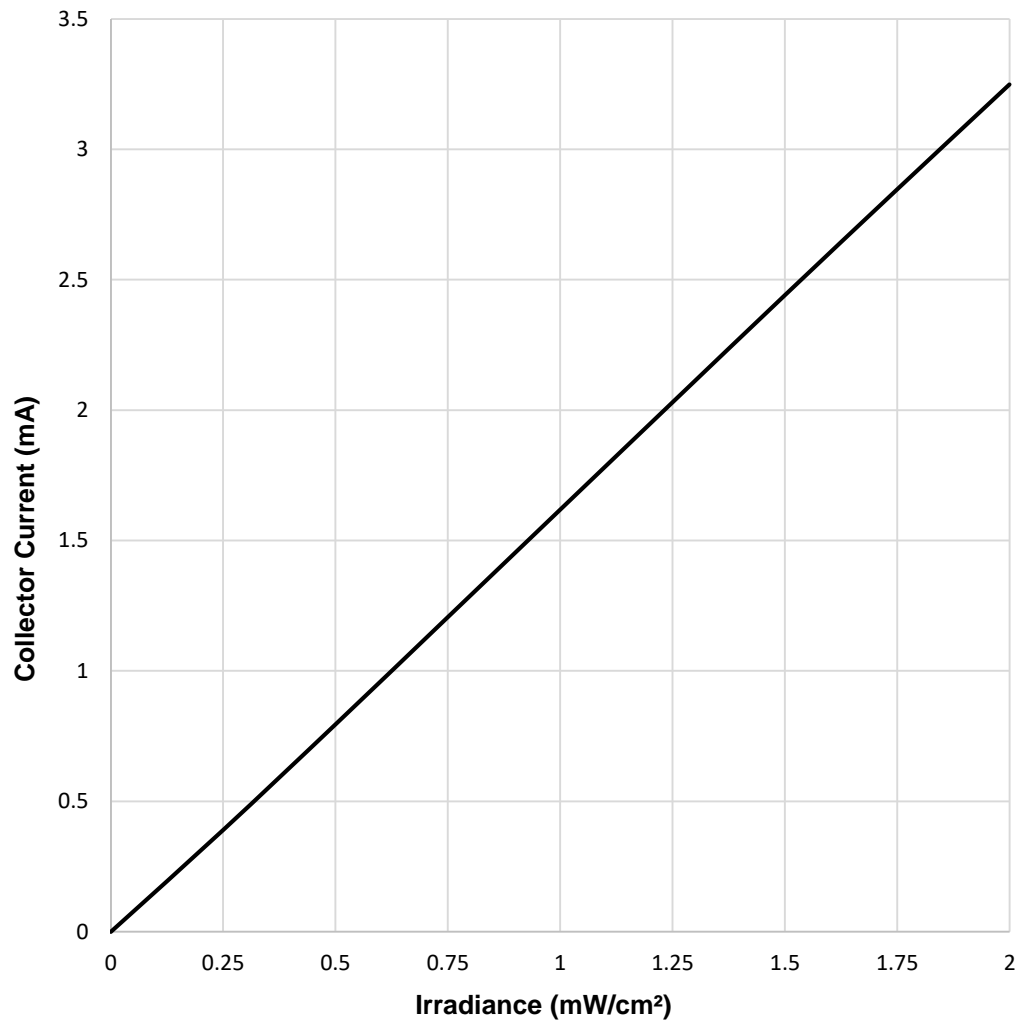

Collector Current vs. Irradiance:

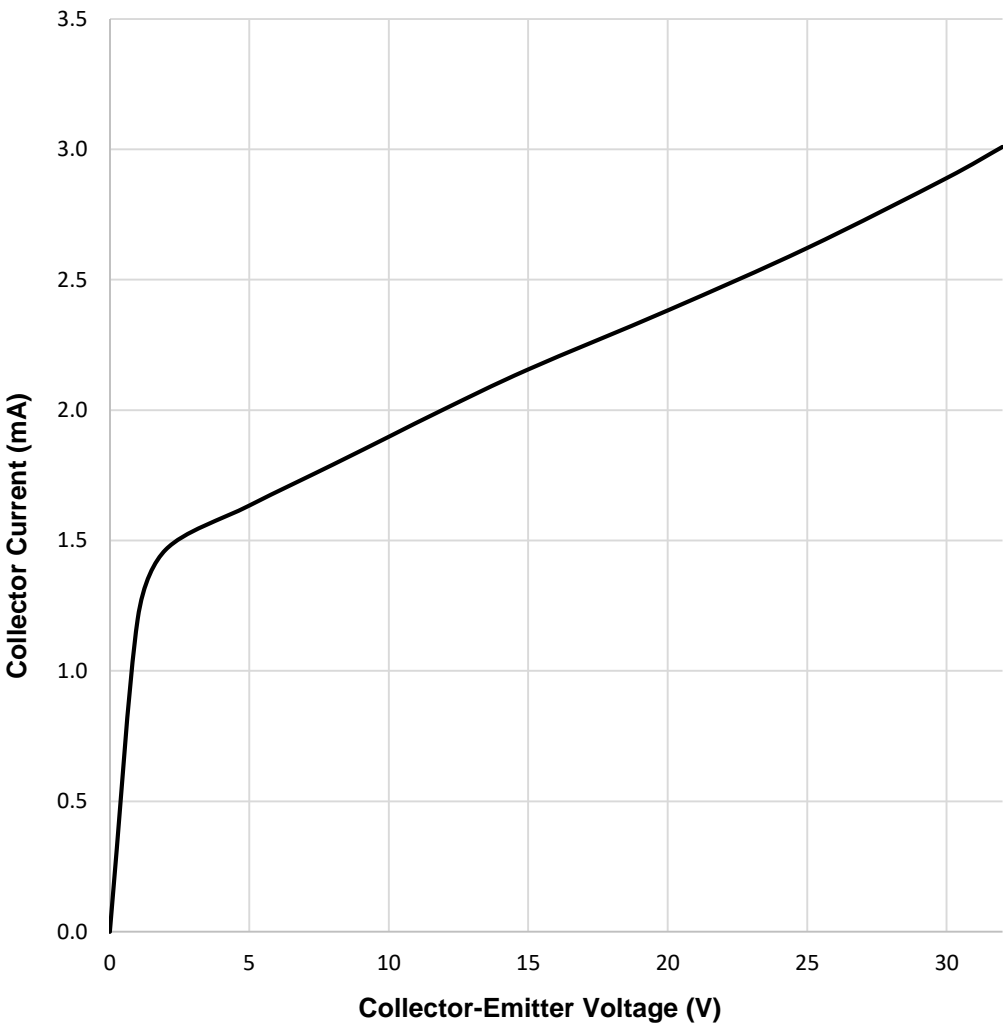

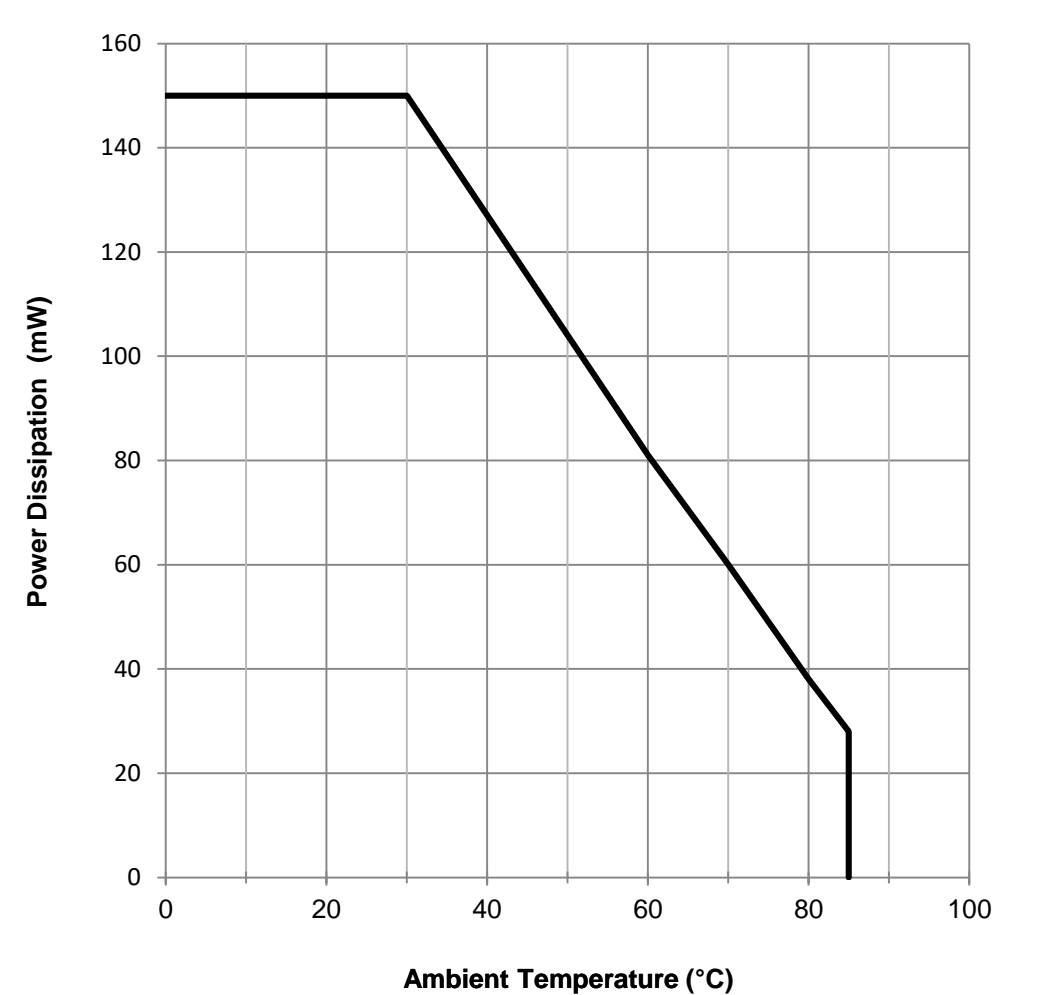



Collector Current vs. Collector-Emitter Voltage:

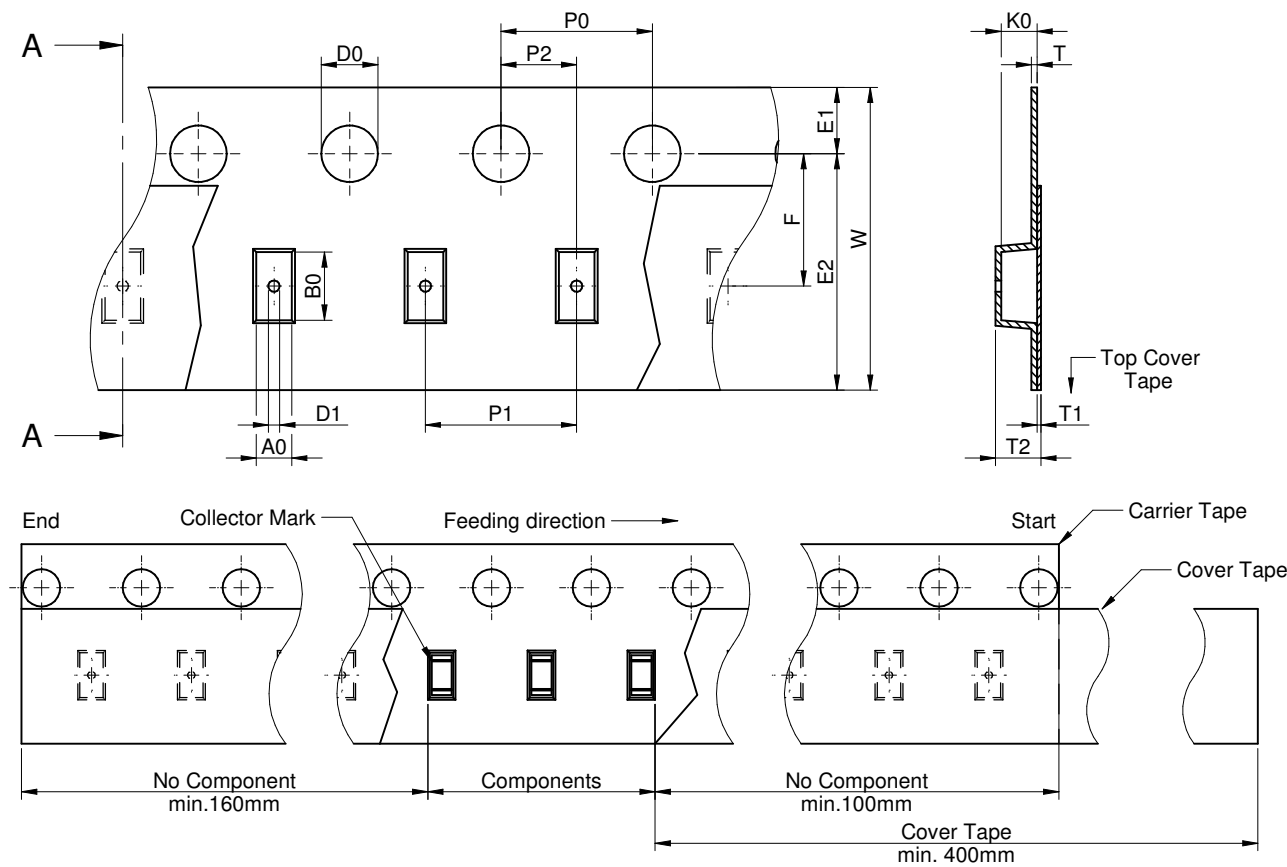
Derating Curve:

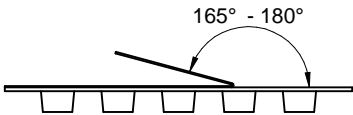

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
