#### **Product specific:**

#### Soldering:

- The solder profile must comply with the Würth Elektronik technical soldering specification. All other profiles will void the warranty.
- · All other soldering methods are at the customer's own risk.

#### **Cleaning and Washing:**

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process could break the module. Therefore, we do not recommend using a brush during the PCB cleaning process.

#### **Potting and Coating:**

If the product is potted in the costumer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the component. Expansion could damage the body, pins or termination of
the product. We recommend a manual inspection after potting to avoid these effects.
