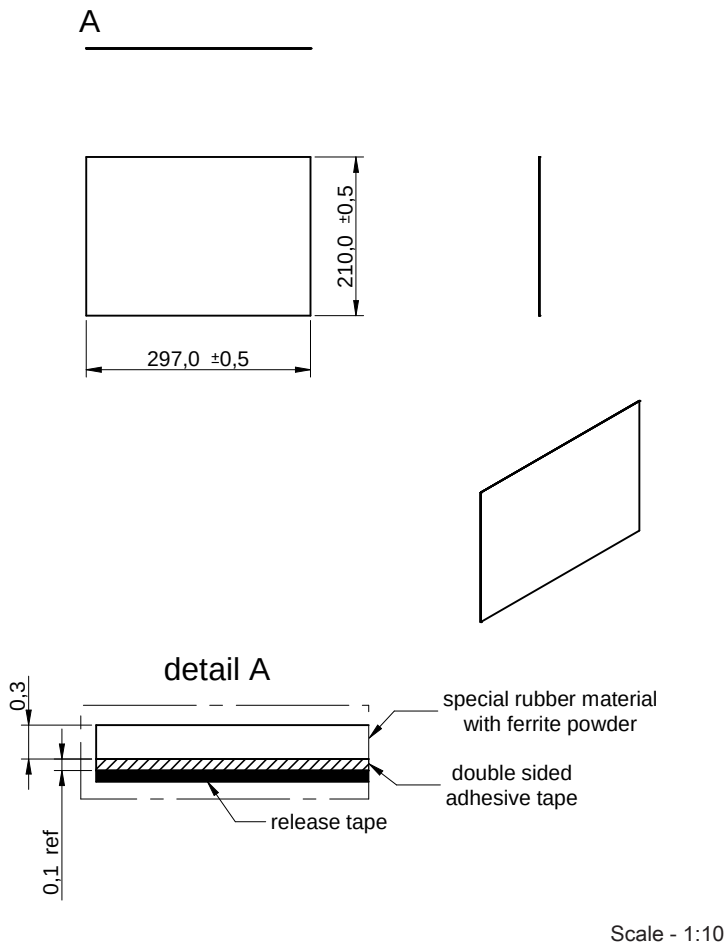

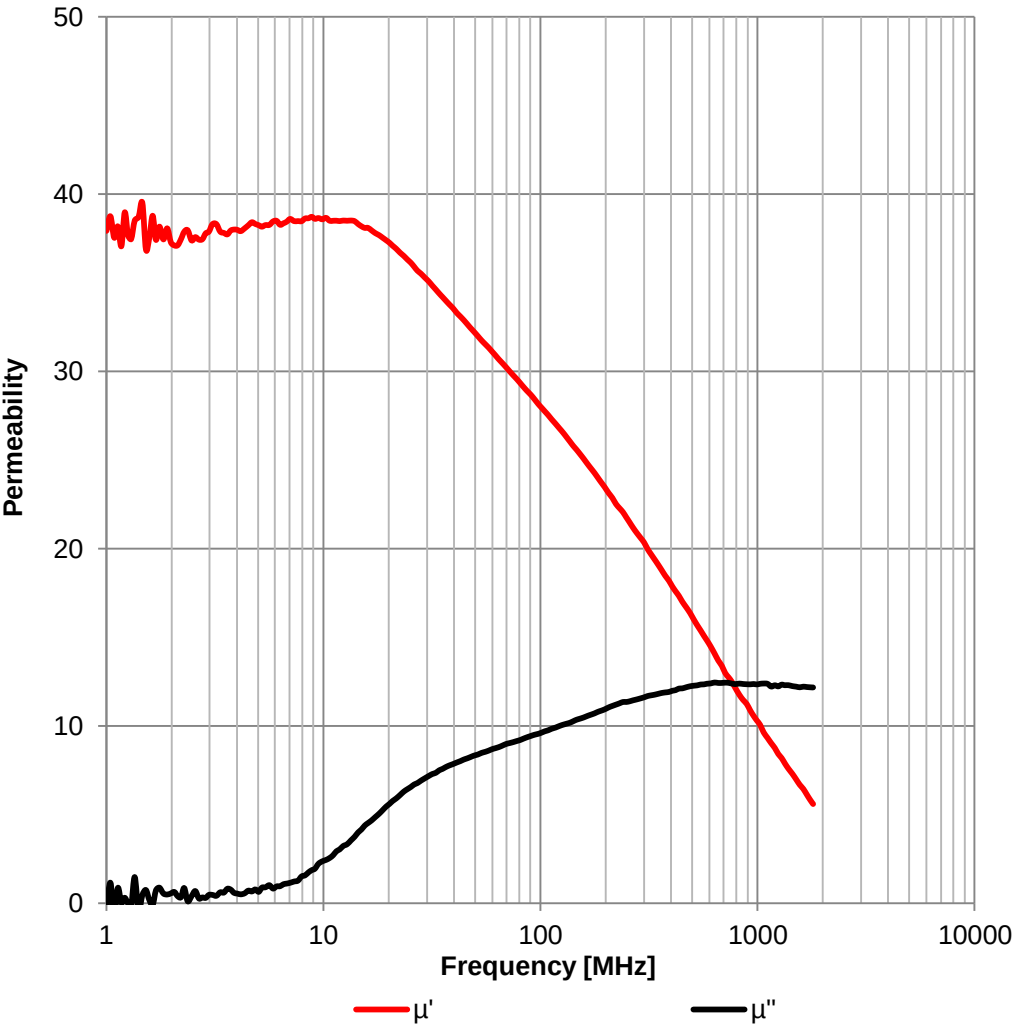


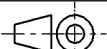

Product specific:

Cleaning and Washing:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

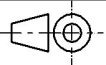
Packaging:

Handling:

6. Product Life Cycle

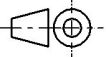
