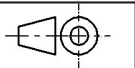
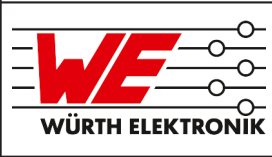
Storage Conditions:

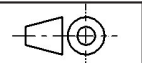
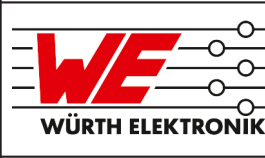
