Product Specific:

Soldering:

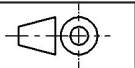
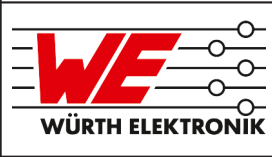
Storage Conditions:

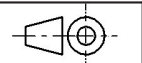
