Soldering:

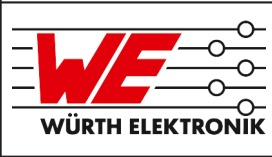
Packaging:

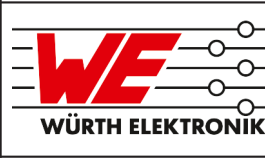
