sectional drawing A-A







Product Specific:

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the components. Washing agents may have a negative effect on the long-term functionality of the product.

Potting and Coating:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.






Packaging:

Handling:

- If a component is pre-assembled with an adhesive tape, the adhesive duration cannot be guaranteed. This depends on the surface where the component will be mounted on. - Coated metal parts may have spots and/or deposits because of the rinsing and drying process during plating. The storage and processability are not affected.


