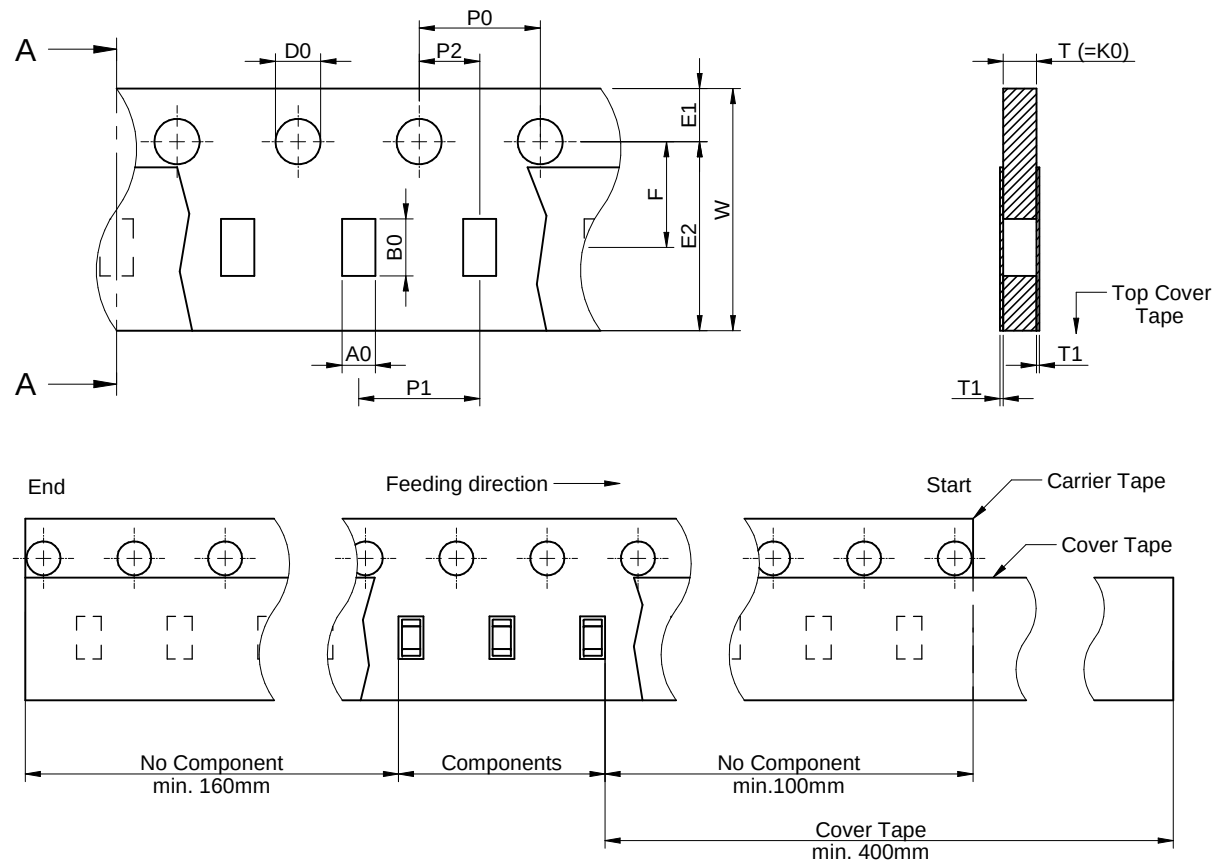
Derating Curve:
