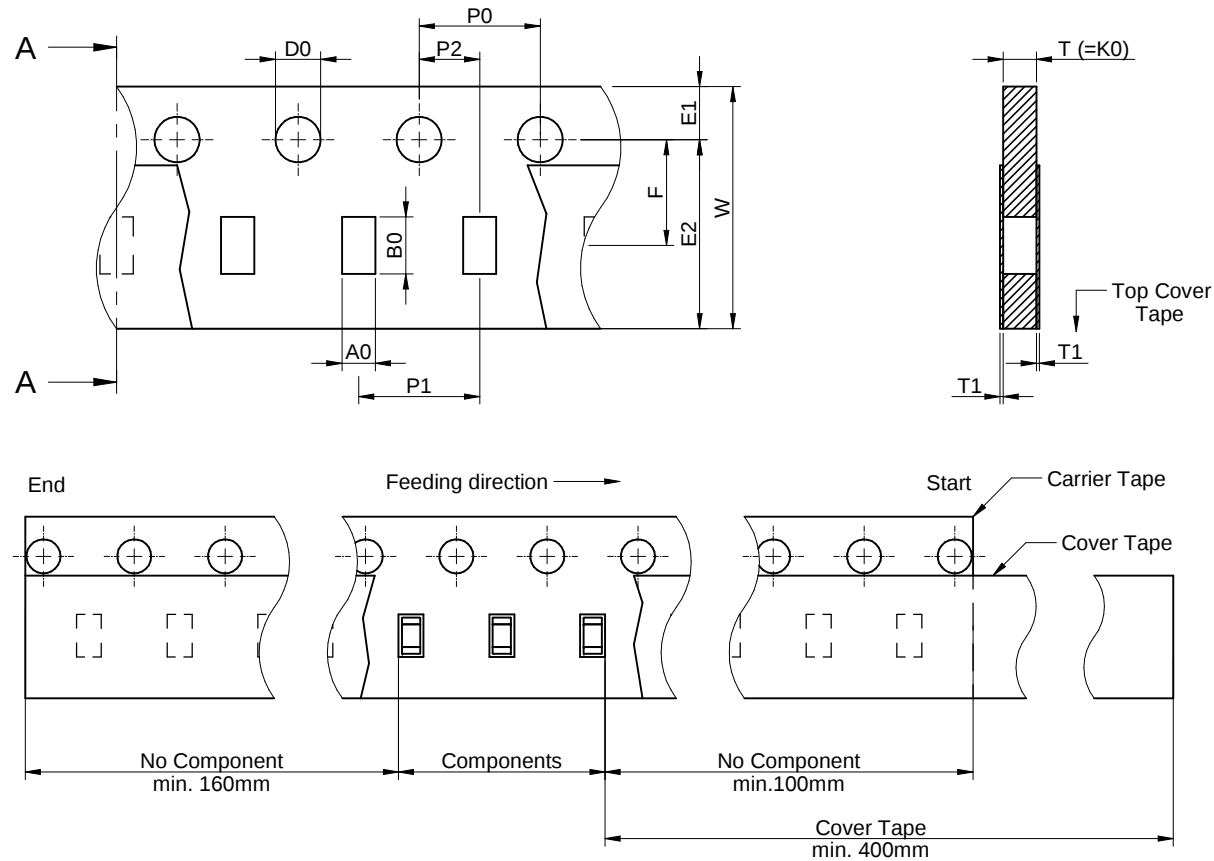

Soldering:
