### Typical Temperature Rise vs. Current Characteristics:

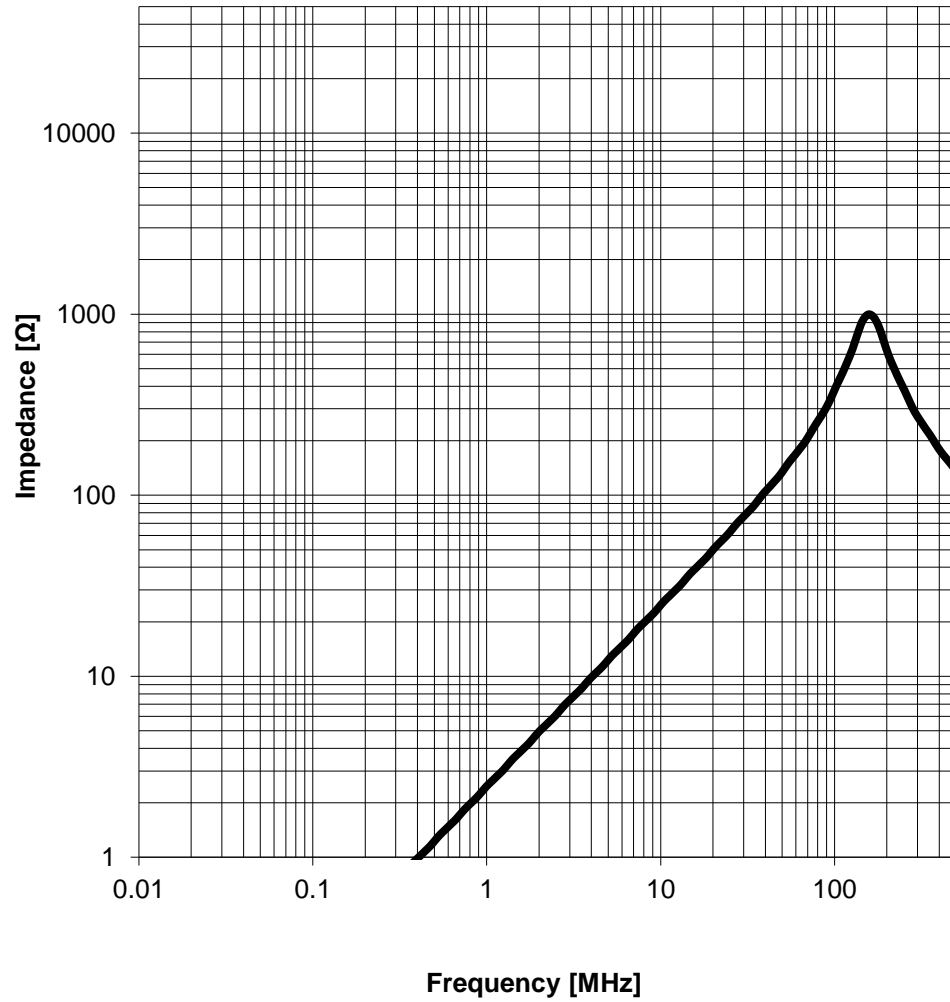










#### Storage Conditions:


