Typical Insertion Loss:



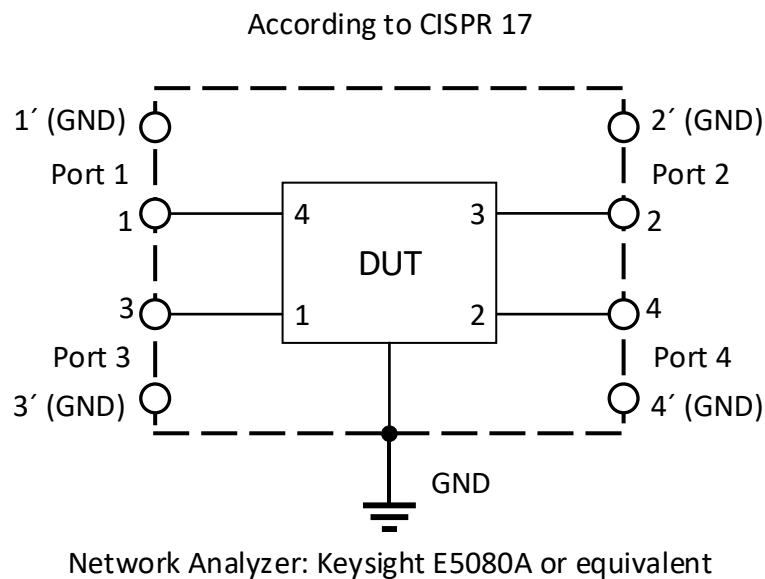
Typical Impedance Characteristics:



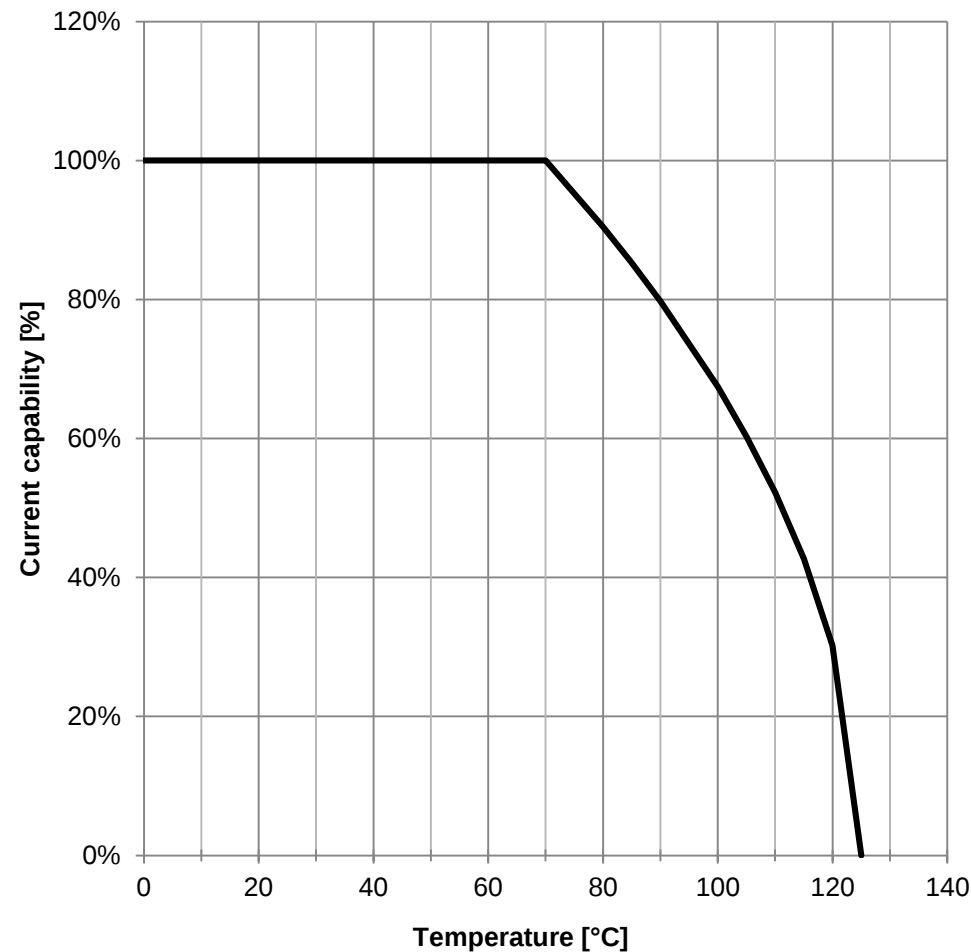
