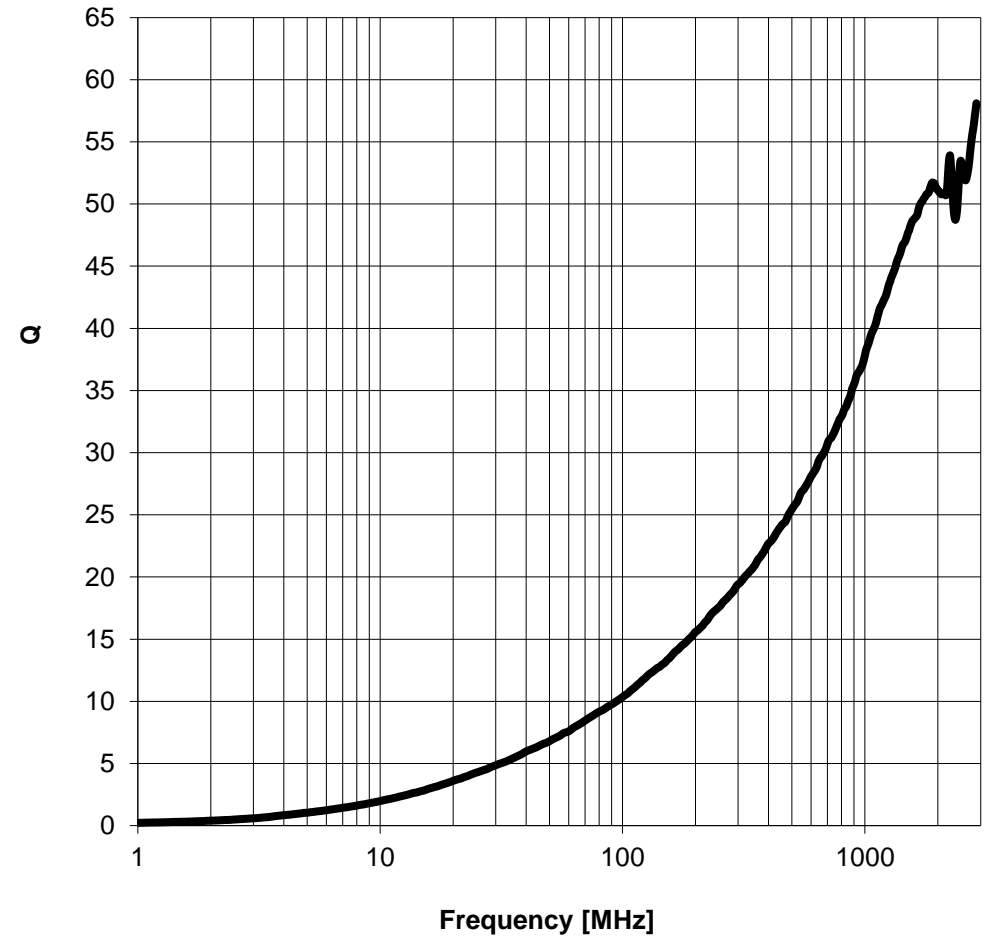

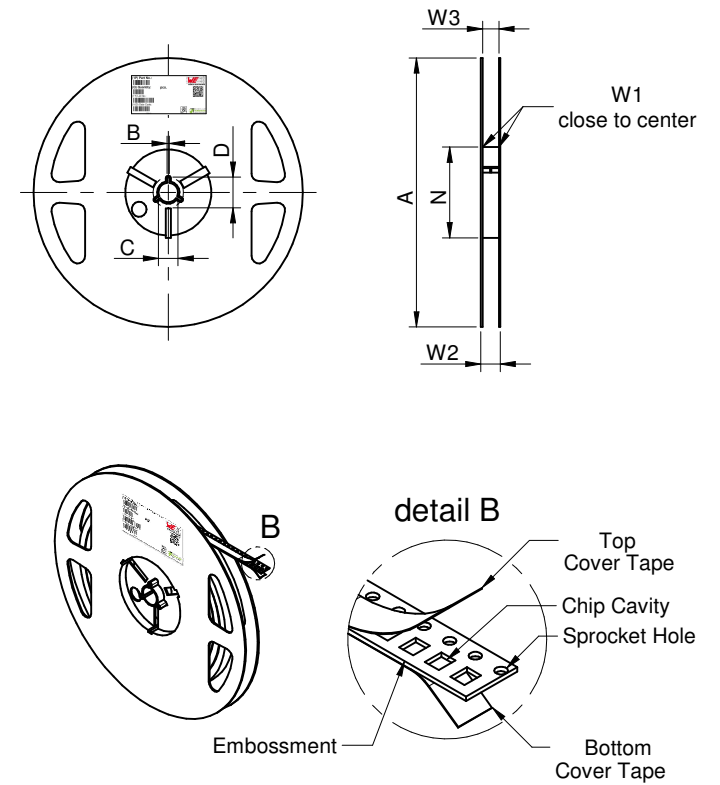



## Packaging:


