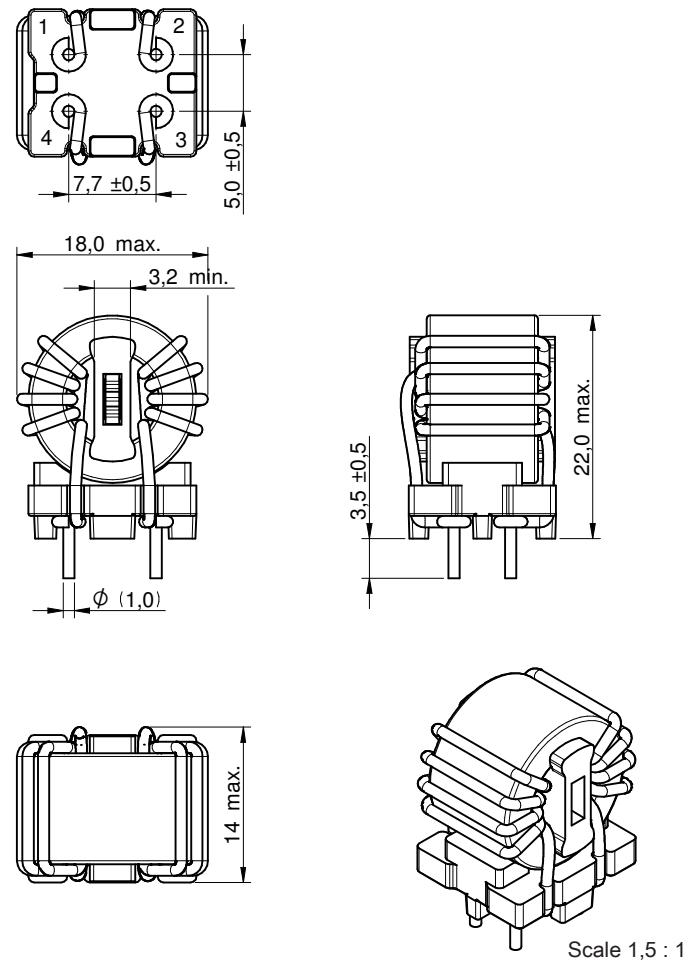
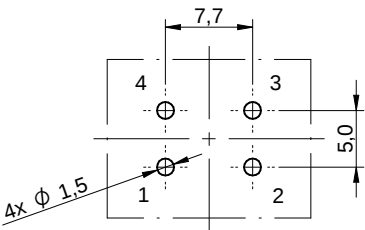

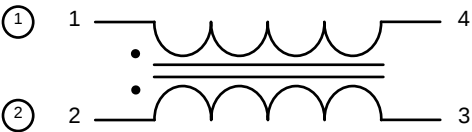


Recommended Hole Pattern: [mm]

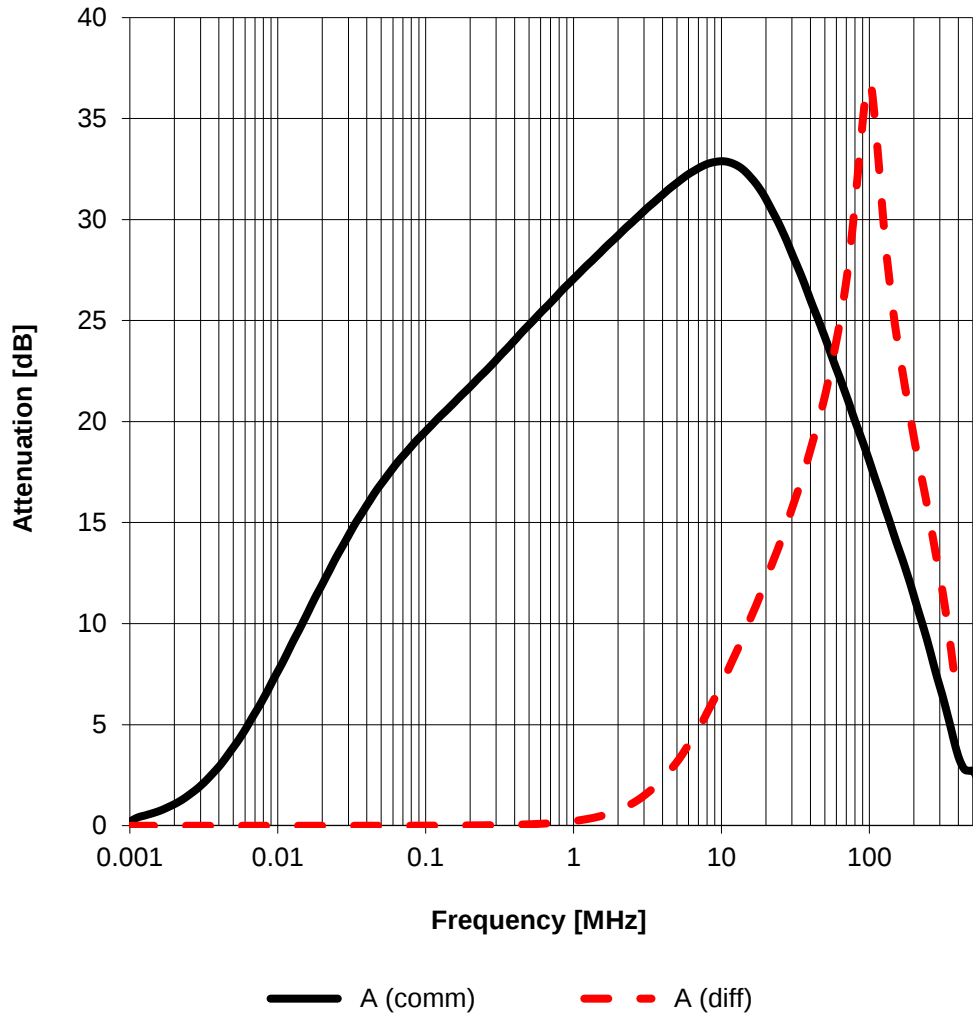

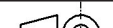

Typical Insertion Loss:



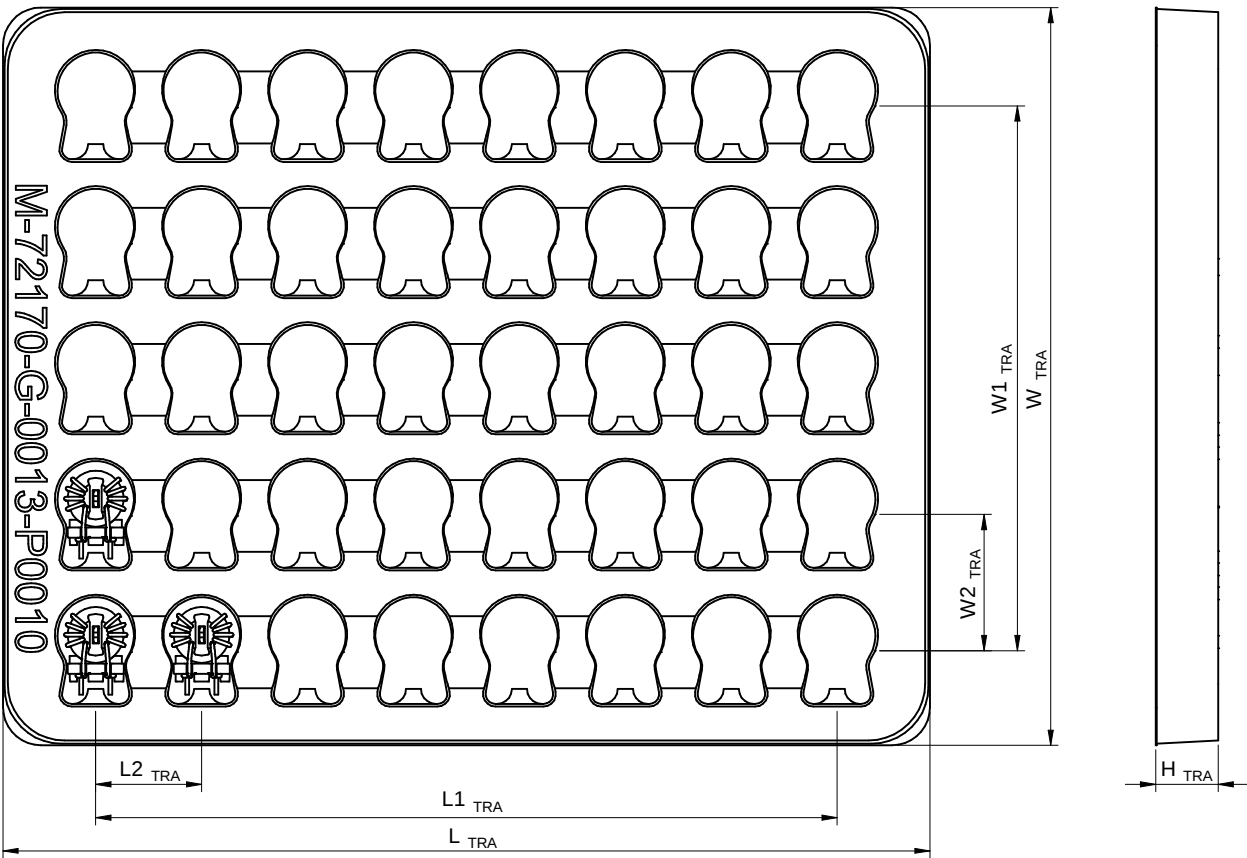

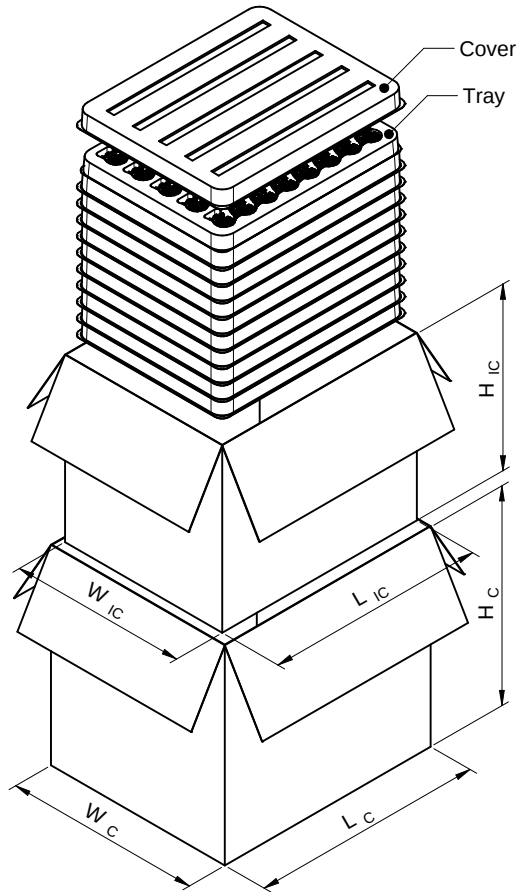

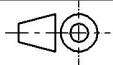

Soldering

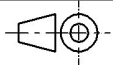
Storage Conditions:

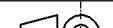
