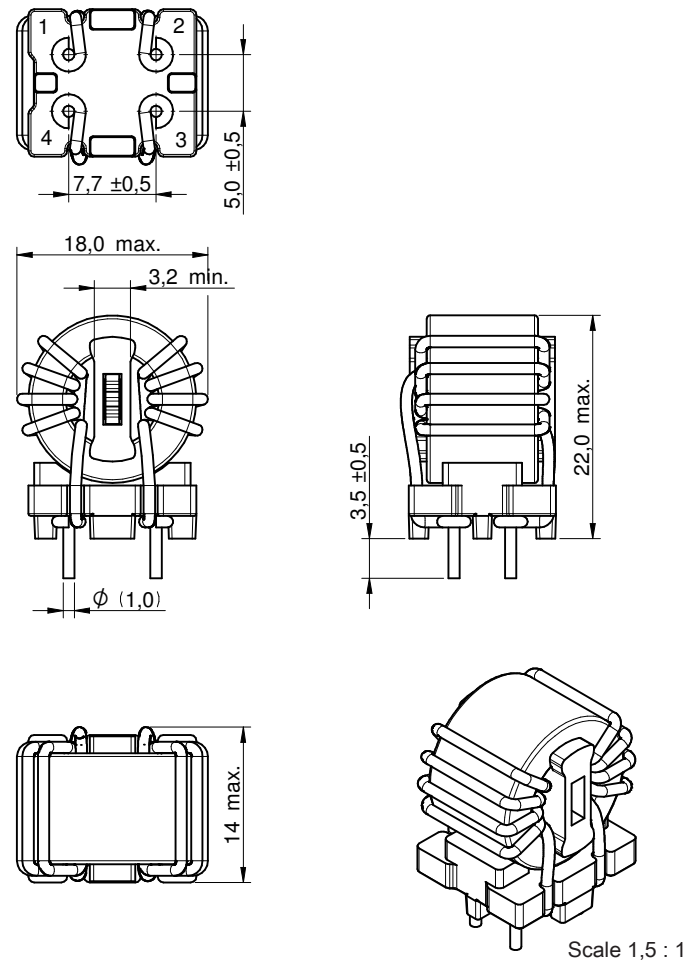
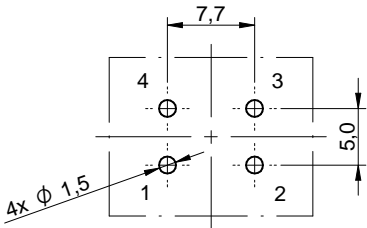

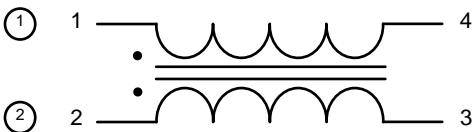


Recommended Hole Pattern: [mm]



Test Setup:



Common Mode

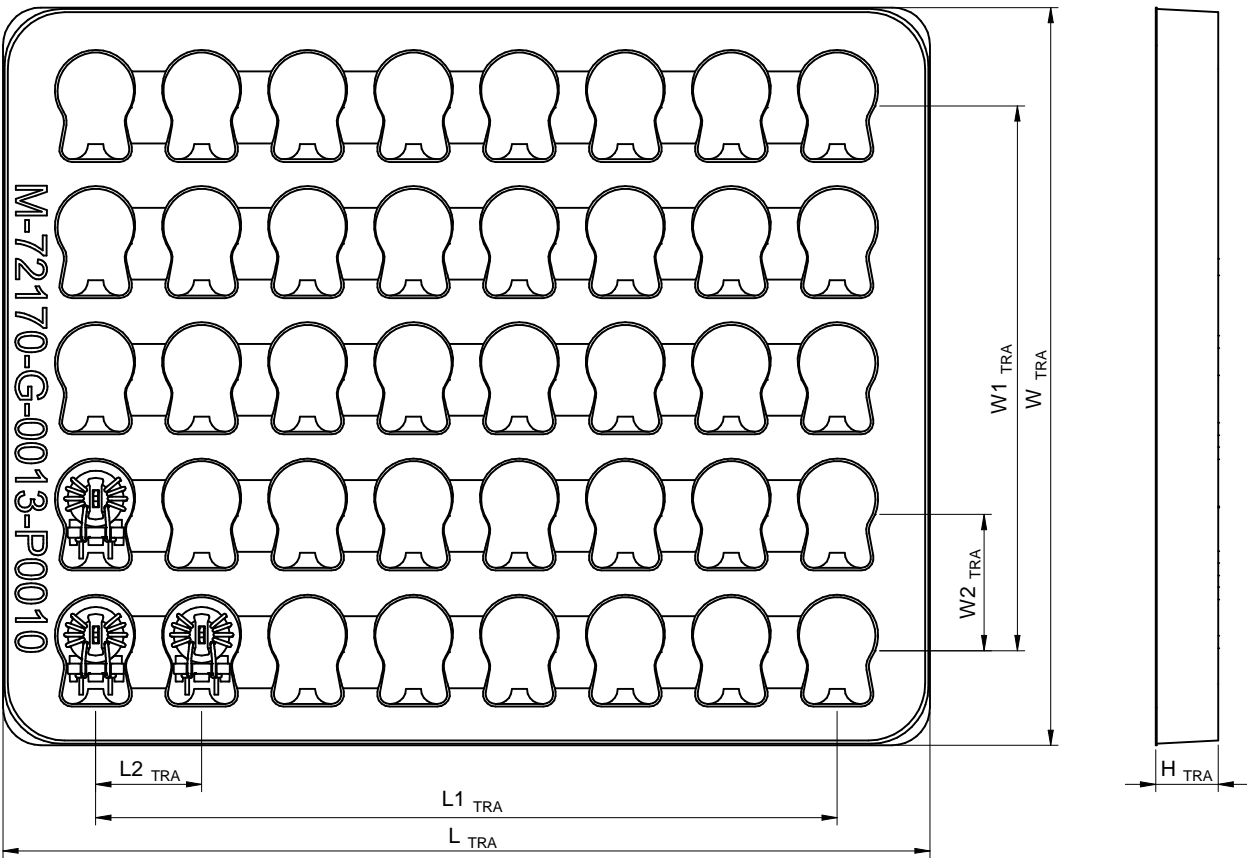


Differential Mode

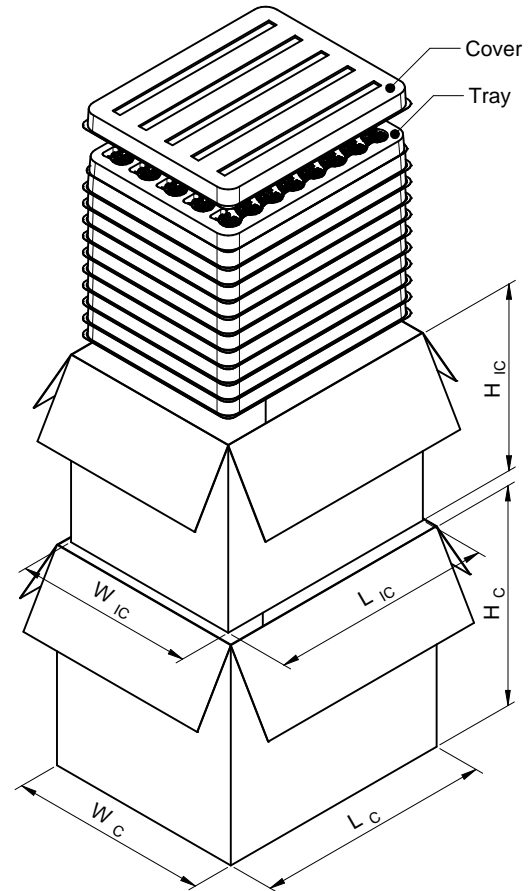



Soldering



Storage Conditions:


