Typical Insertion Loss:



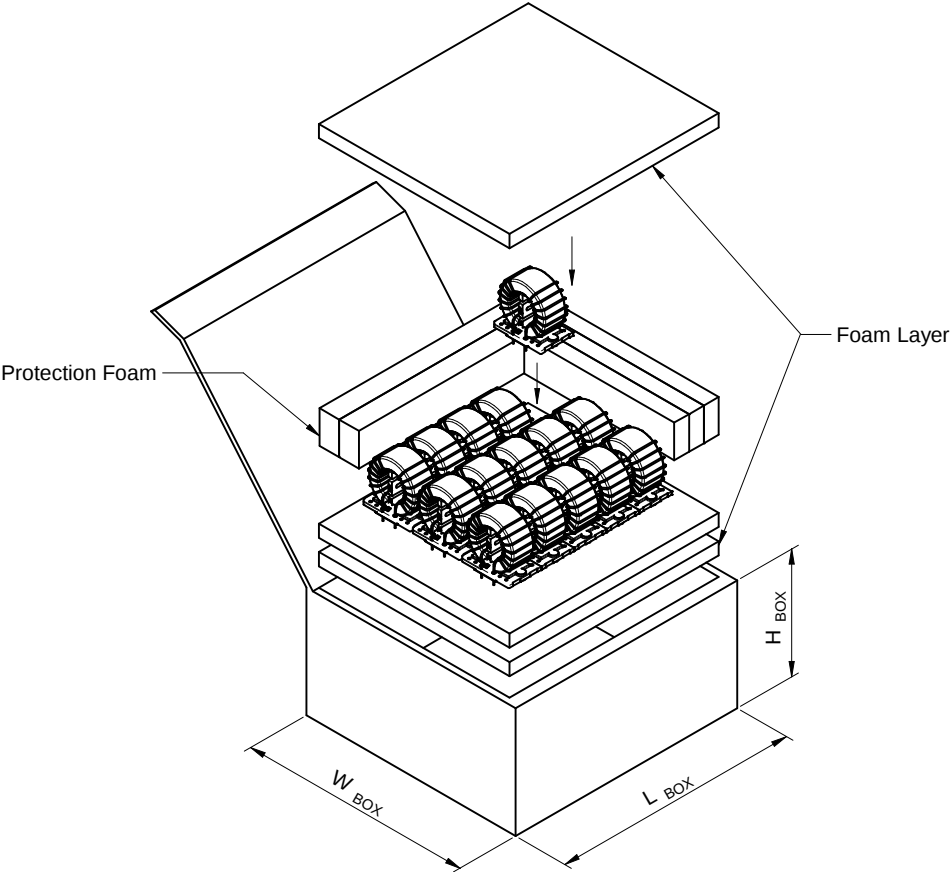

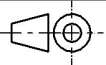
