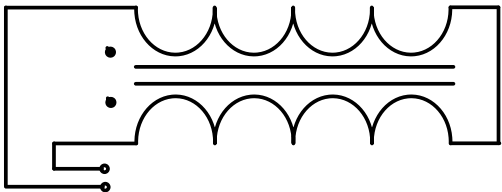
Typical Insertion Loss:



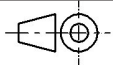

Common Mode

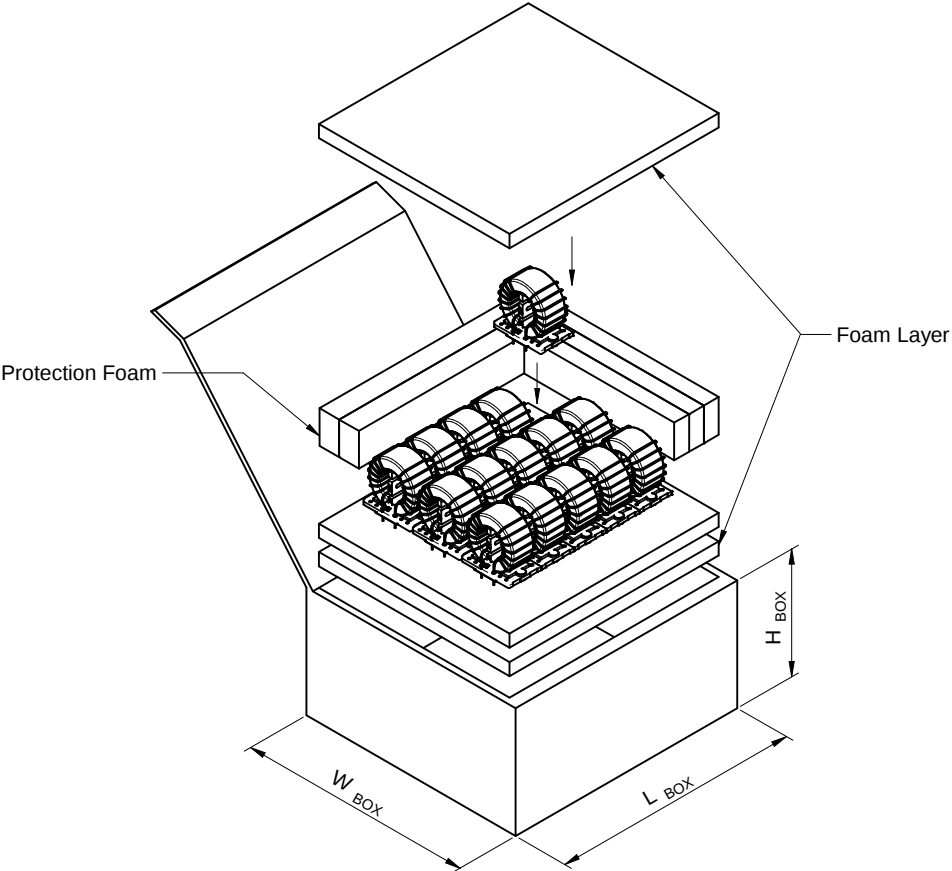


Differential Mode

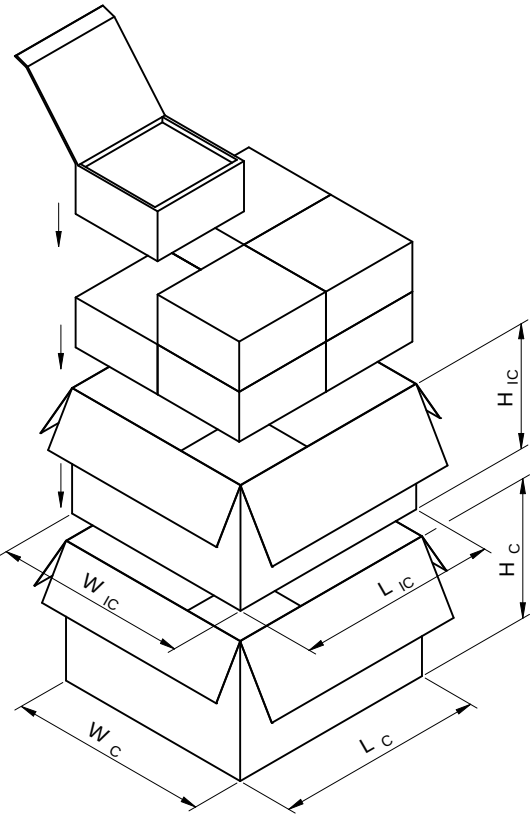
