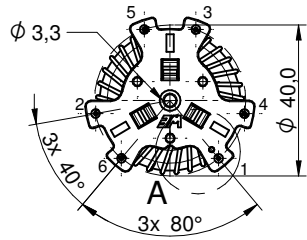
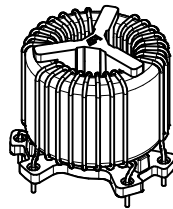
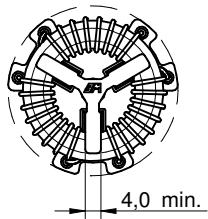
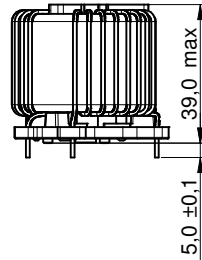
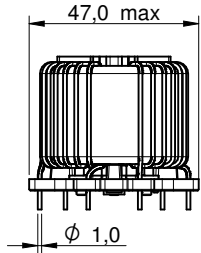
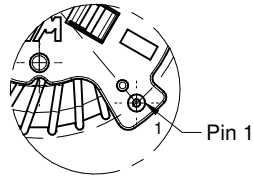


### Recommended Hole Pattern: [mm]



## Storage Conditions:


