



Differential Mode

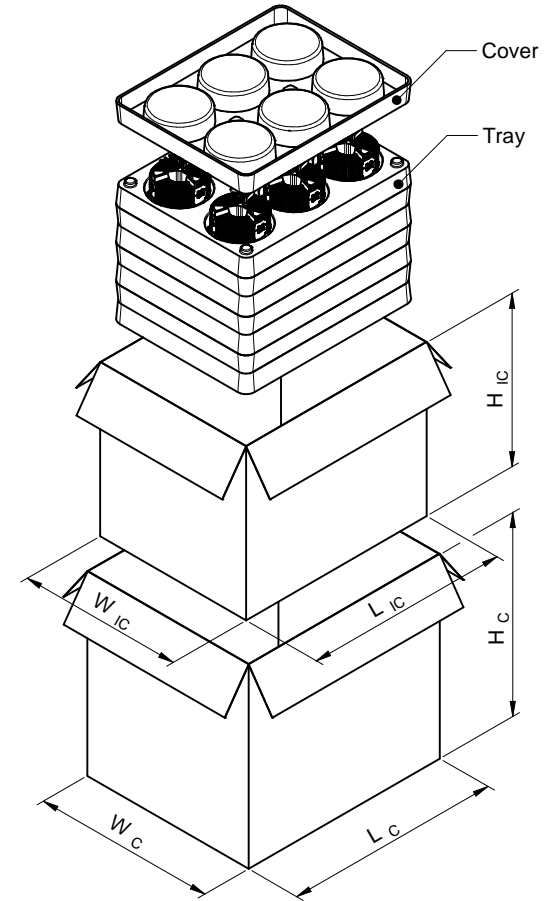
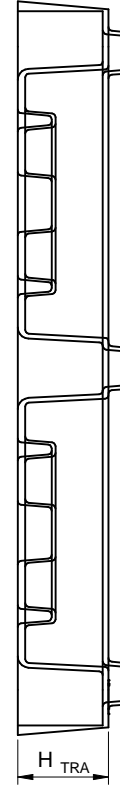
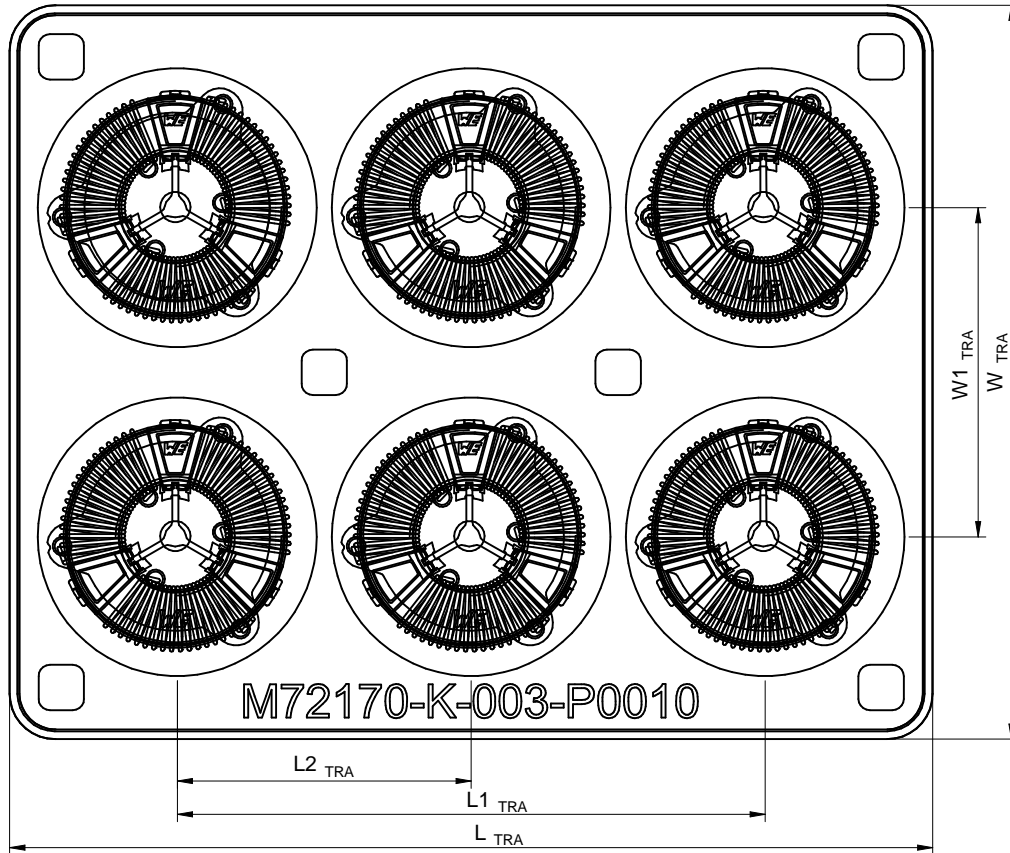


## Typical Insertion Loss:



## Storage Conditions:

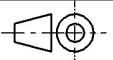
