Differential Mode



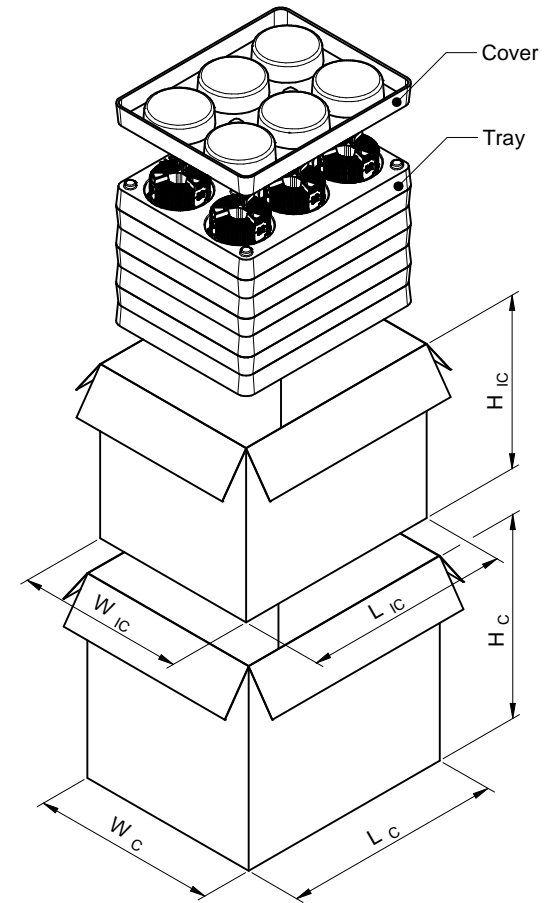
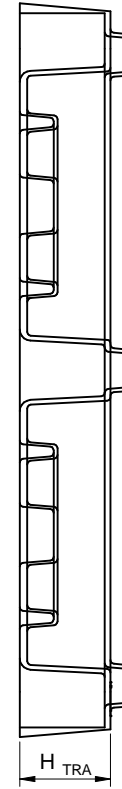
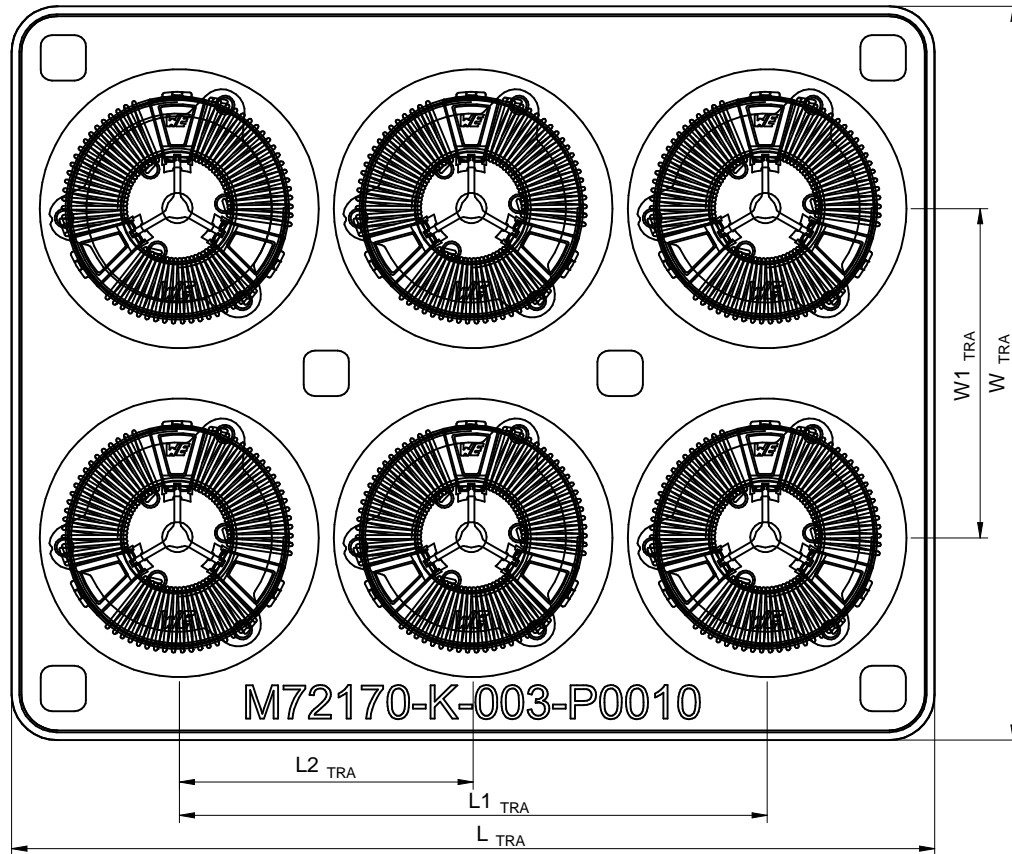



## Storage Conditions:


