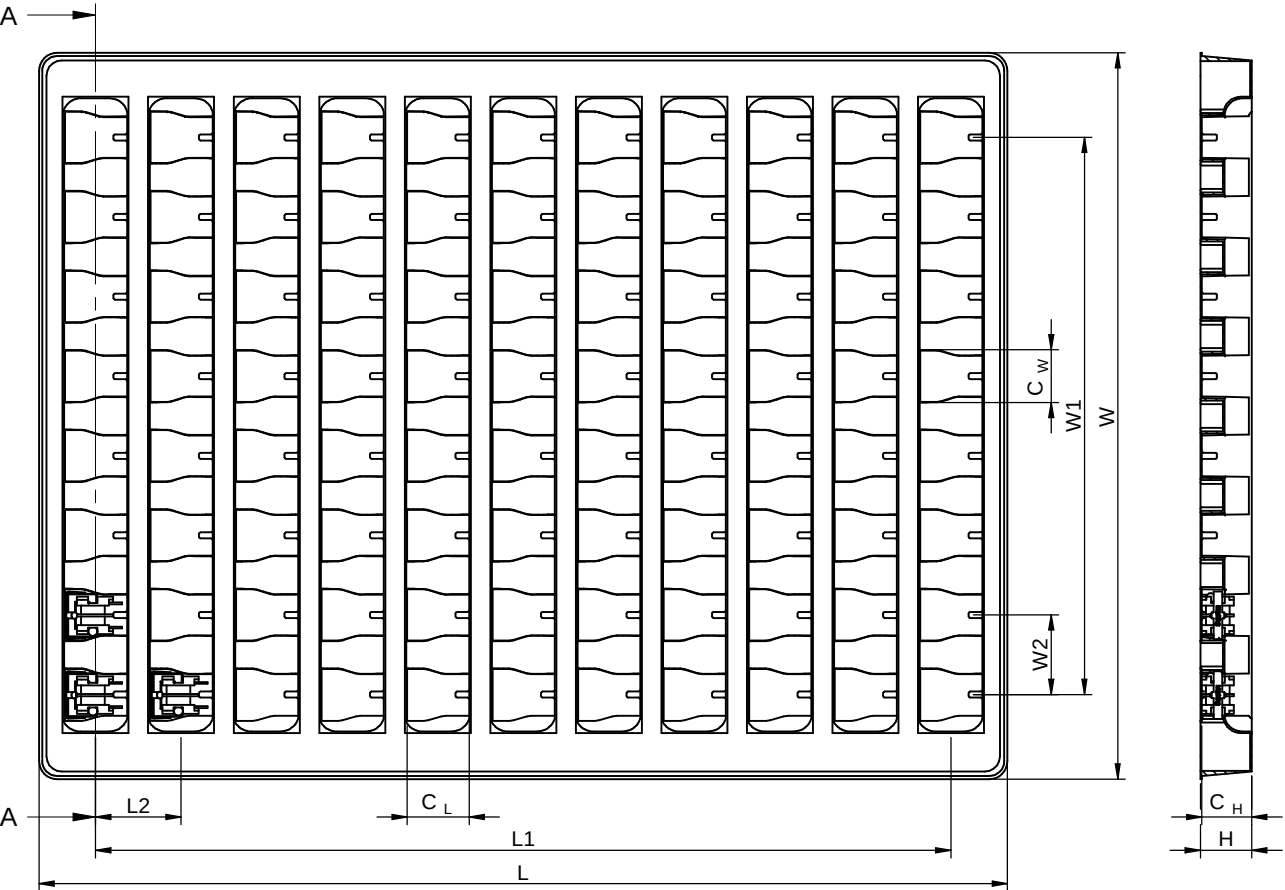


Derating Curve:

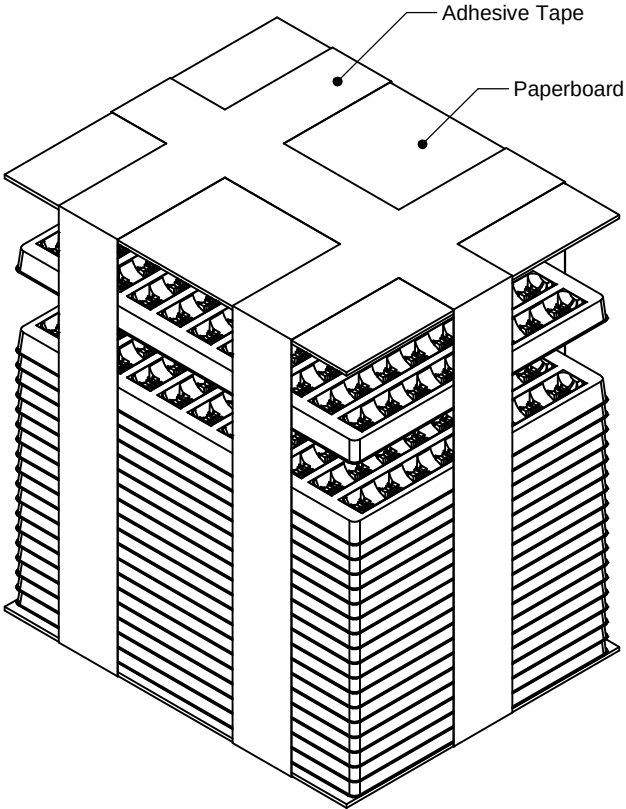
