Recommended PCB Layout [mm]:



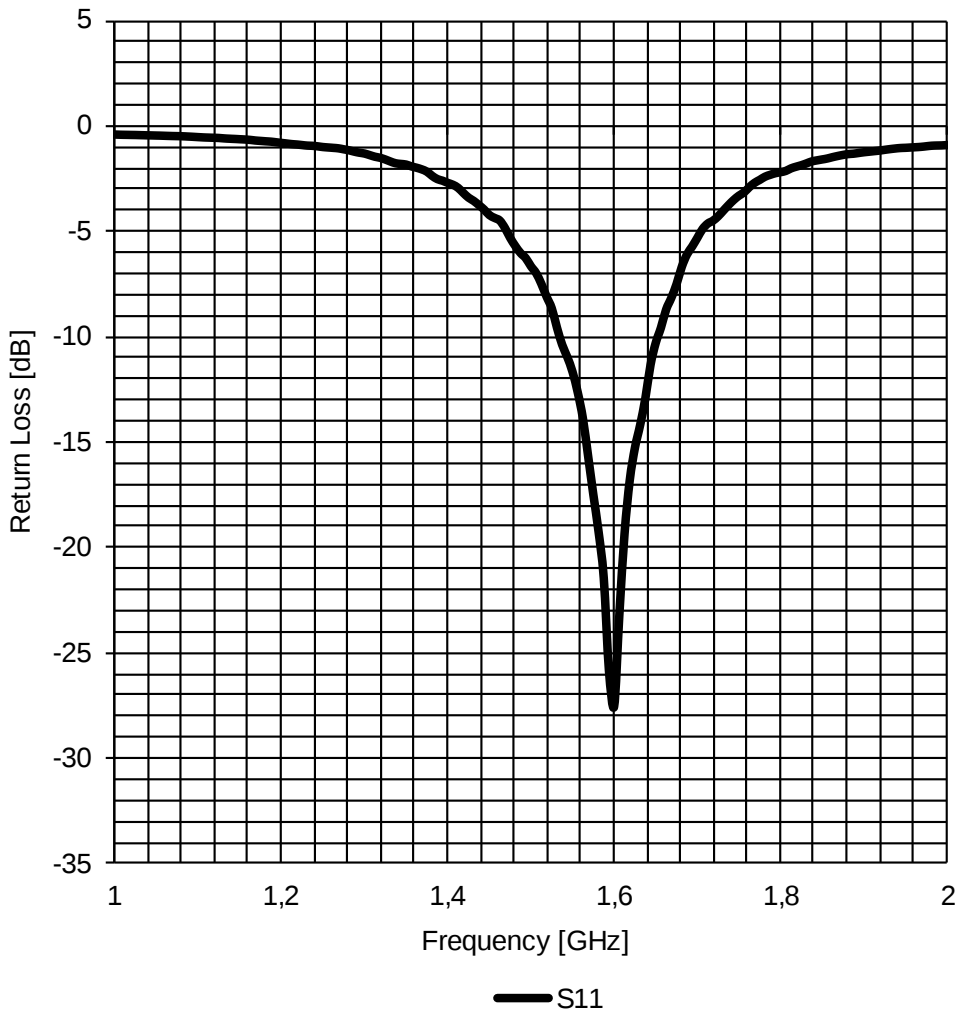
