Soldering:

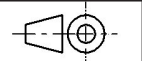
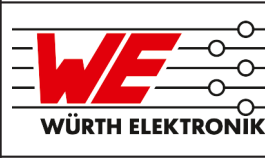
Storage Conditions:

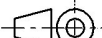
