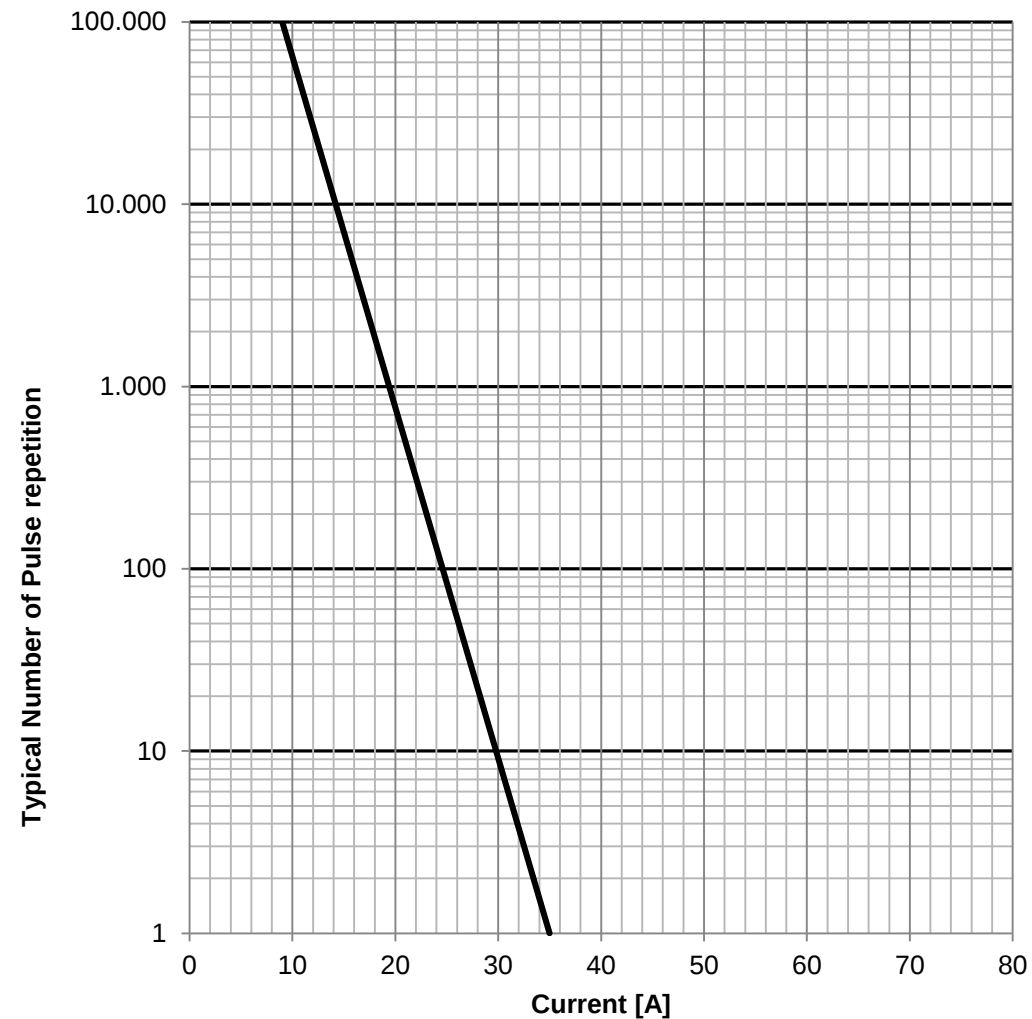

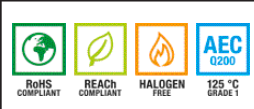
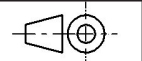
Storage Conditions:
