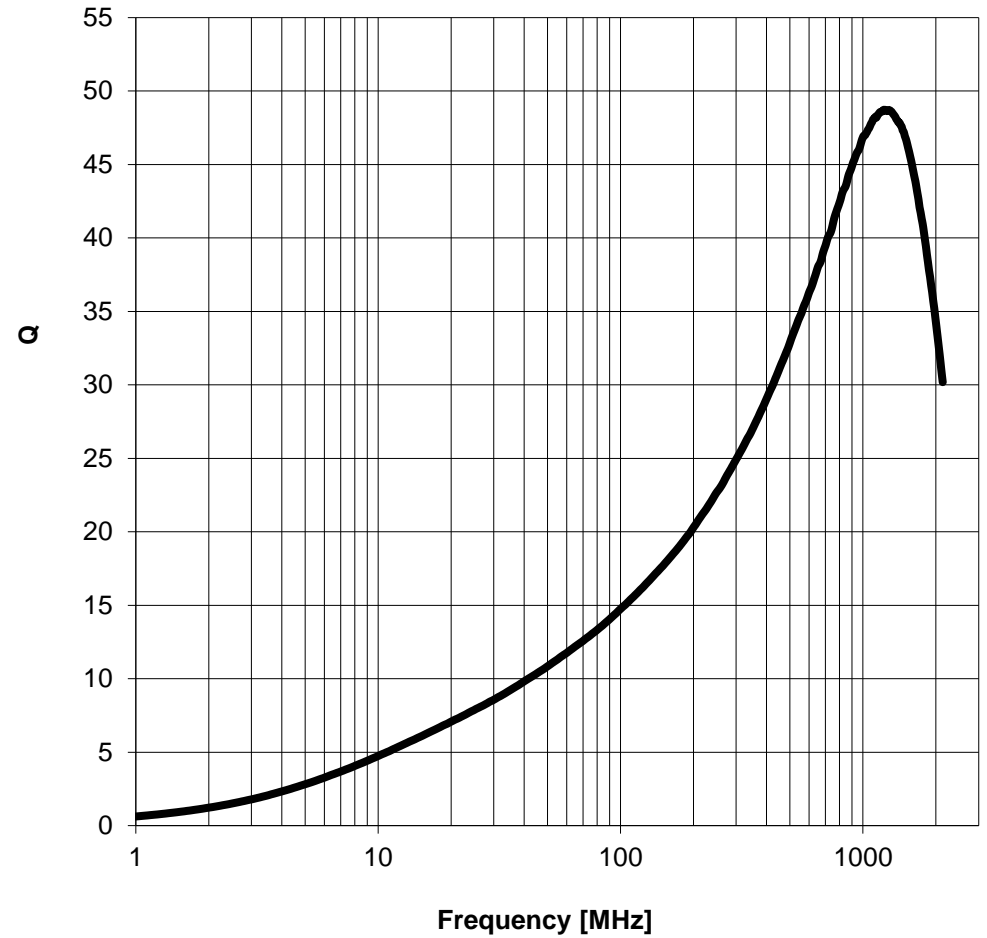

### Q-Factor vs. Frequency:

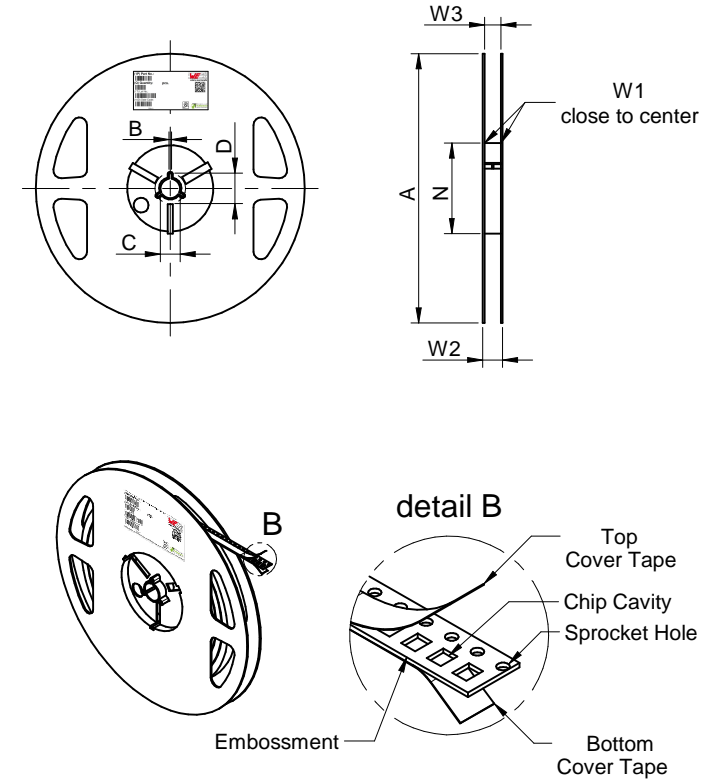

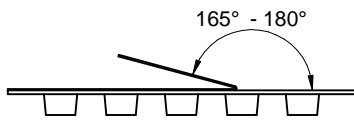



## Storage Conditions:


