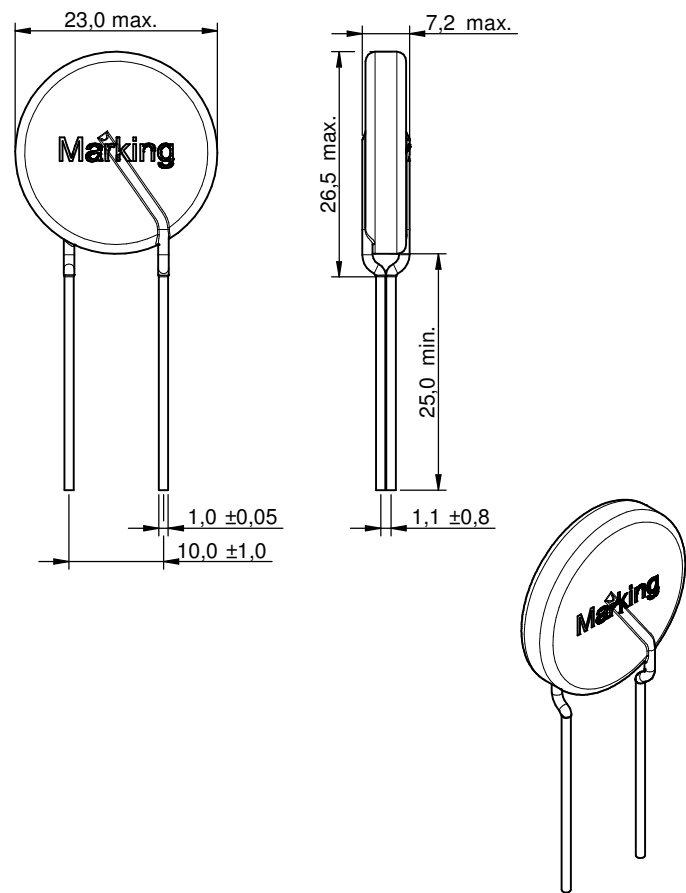

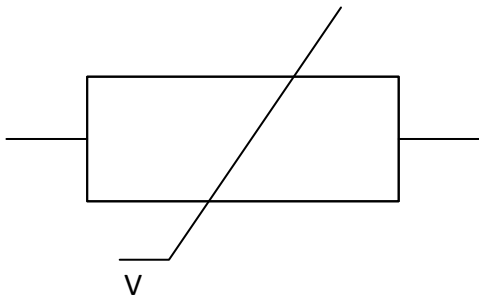

Rated Current vs. Voltage:



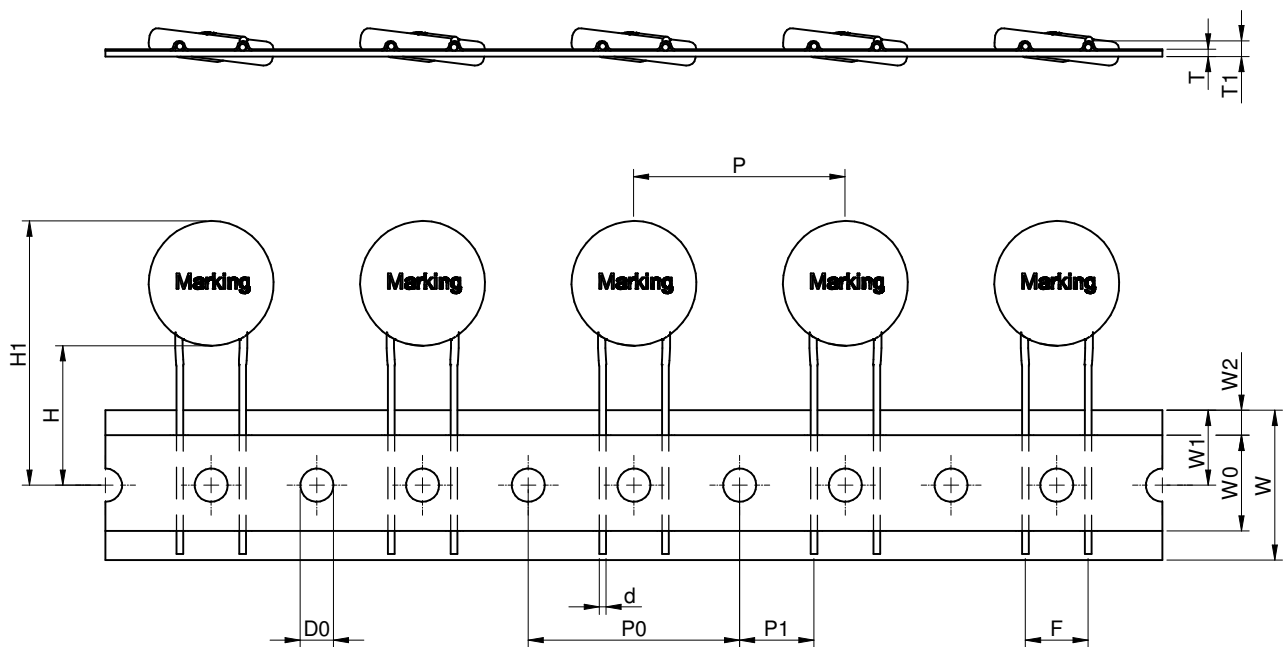

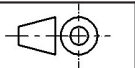
Storage Conditions:

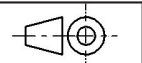
