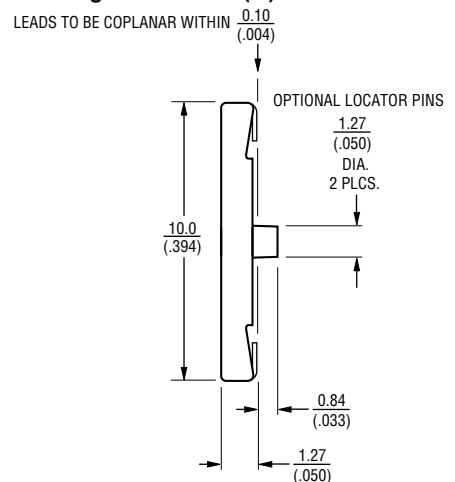

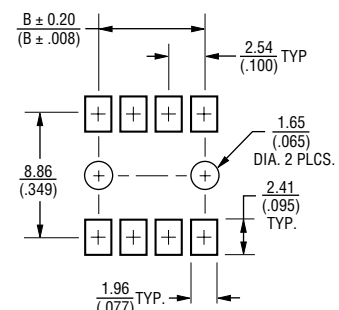
### Standard Version (-0)

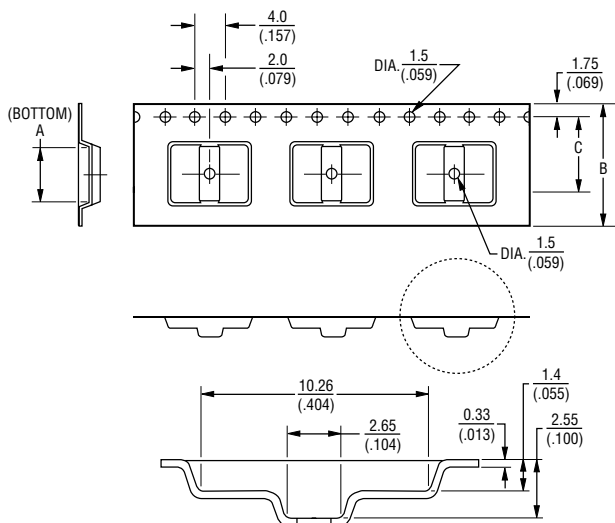

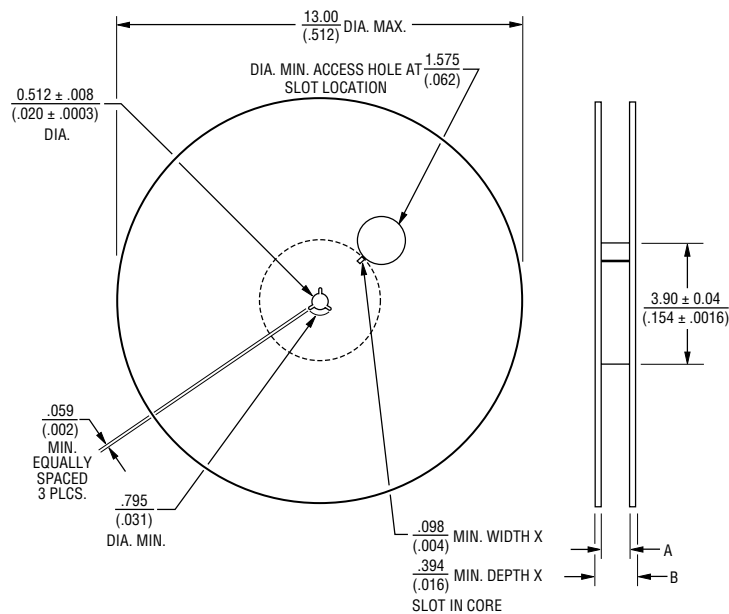
