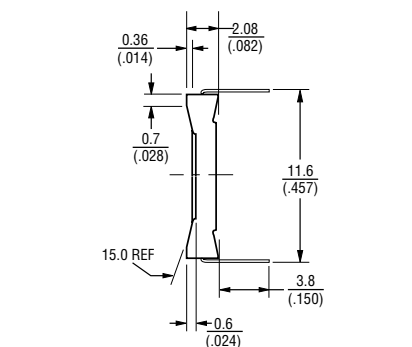
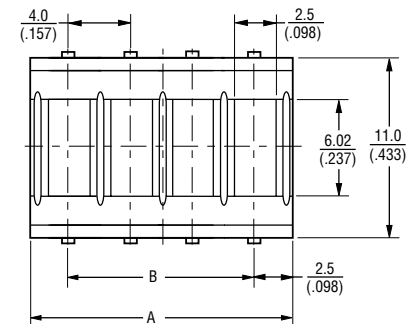
70ADJ RECOMMENDED PWB MOUNTING PATTERN



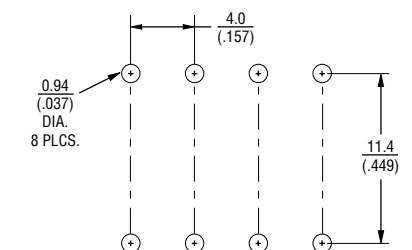
