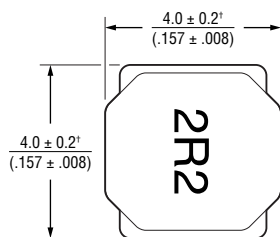

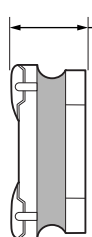

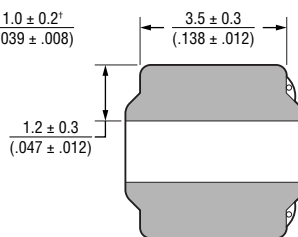

SIDE VIEW

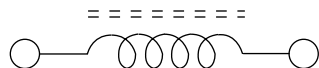


BOTTOM VIEW
