

The devices offer 400 watts peak pulse power dissipation capability in a very compact, low-profile DFN3419 package. The package footprint is compliant with most SOD-123 and SOD-123F footprints. Both unidirectional and bidirectional options are available with a range of breakdown voltages.





#### **Peak Pulse Power Rating Curve**




### **Steady State Power Derating Curve**
