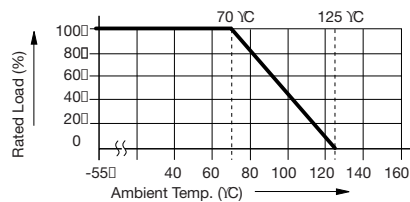

Land Pattern



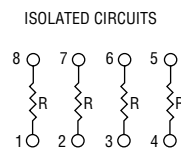
Derating Curve

Isolated Circuit

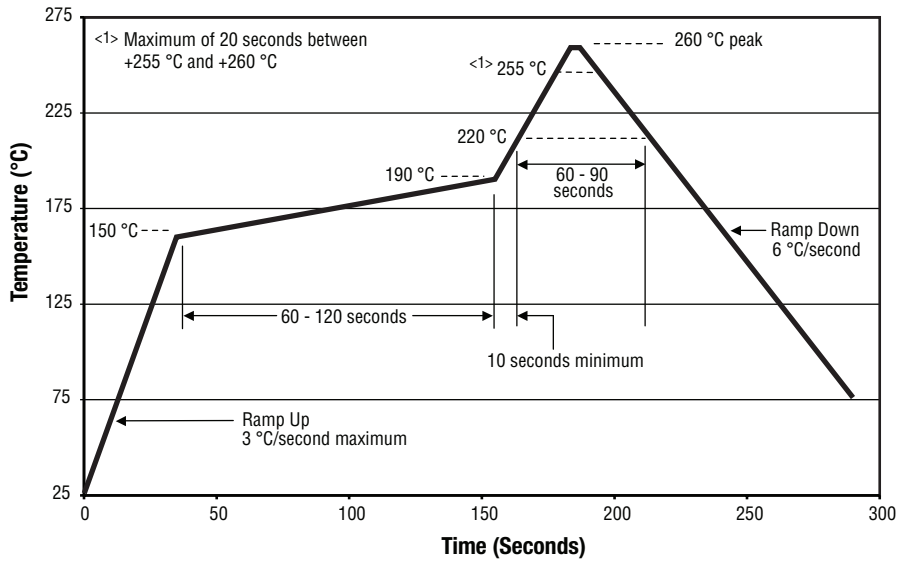

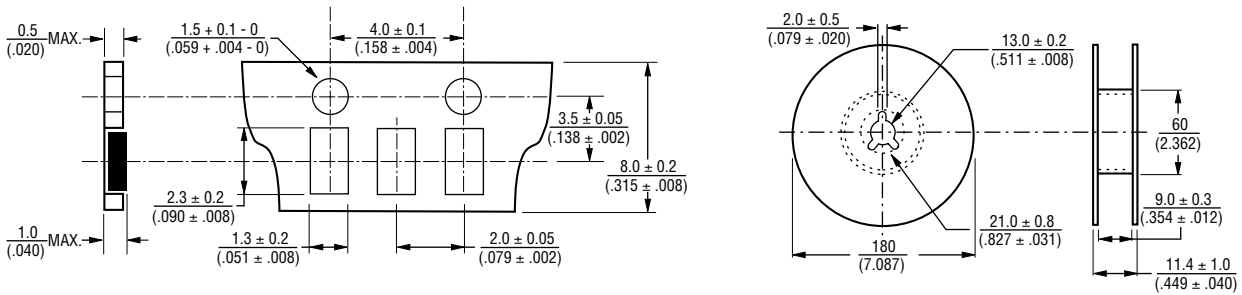
