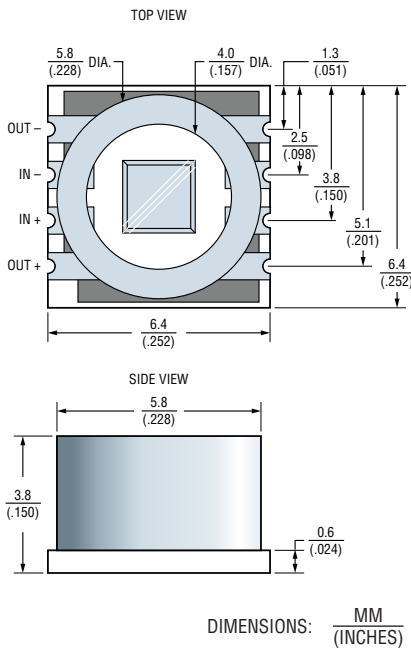

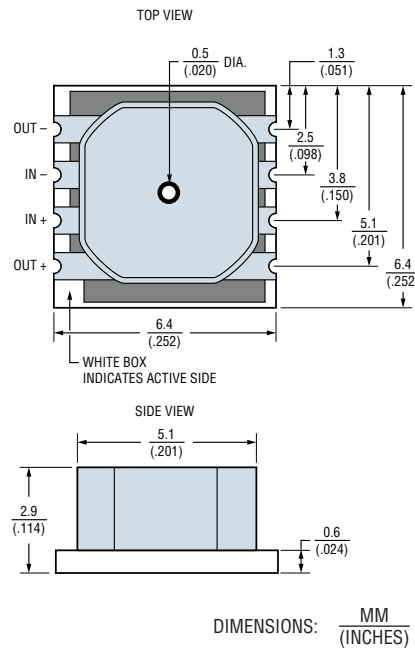

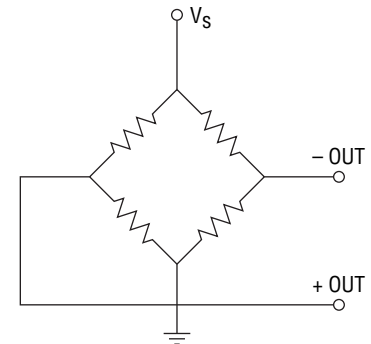
Ceramic Chimney Dimensions

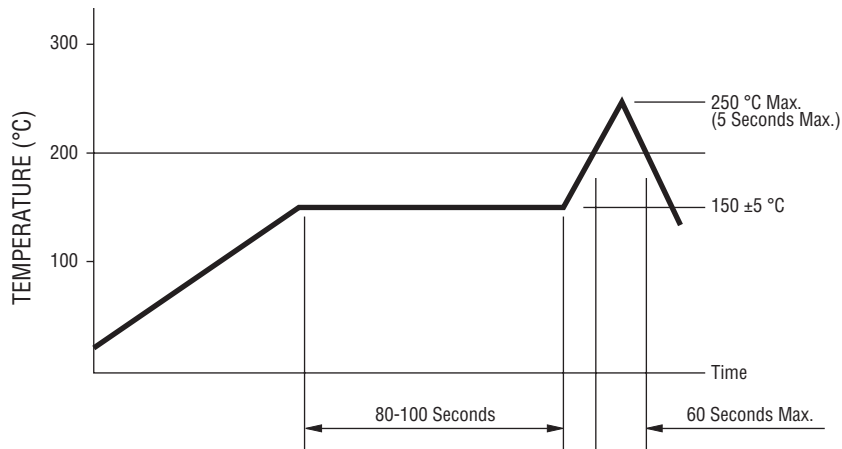

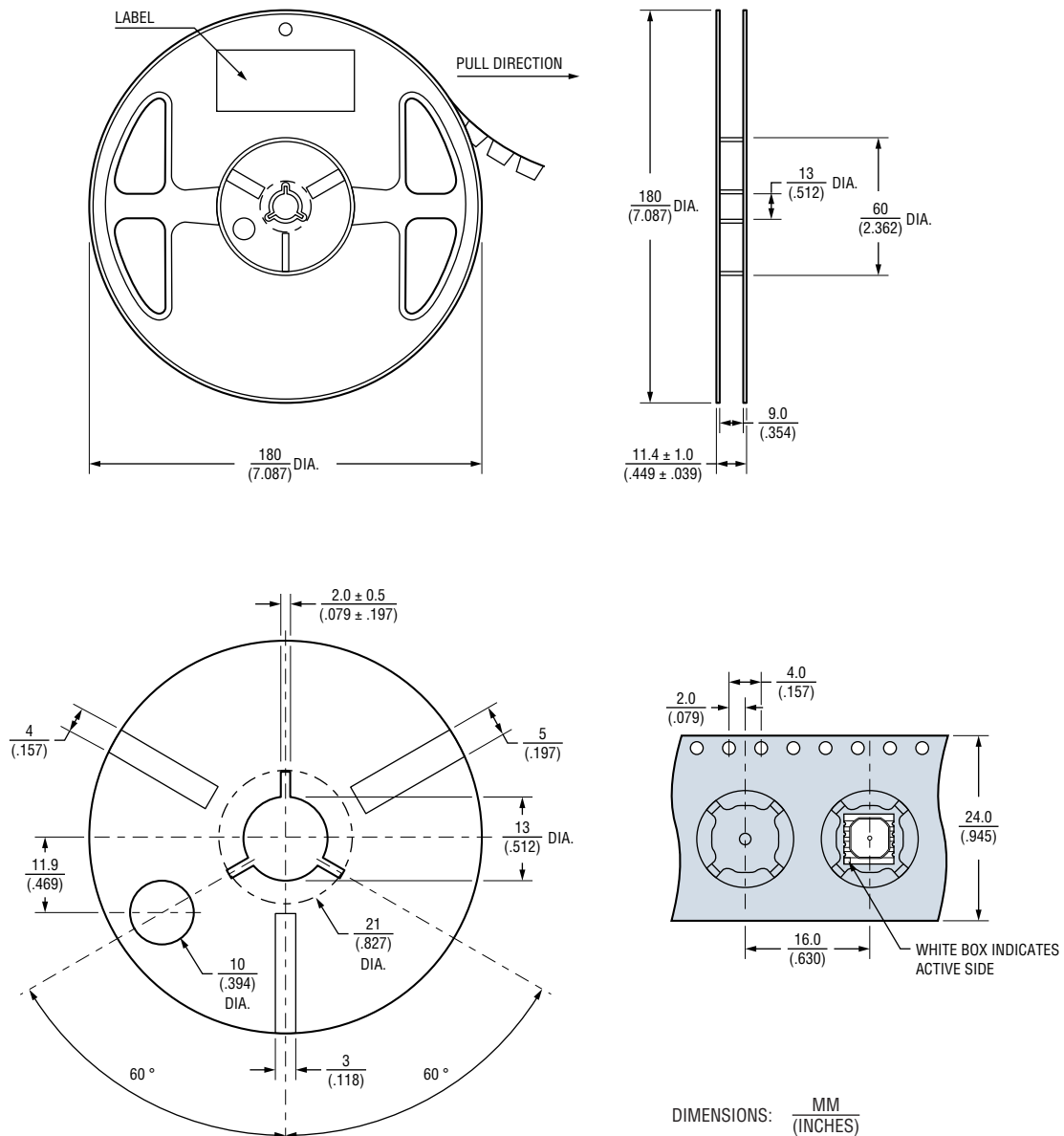
