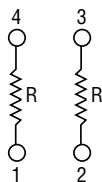

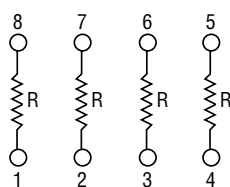

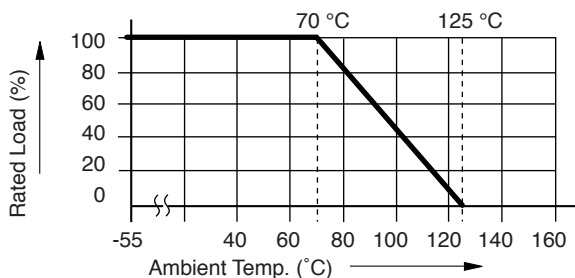

### Derating Curve

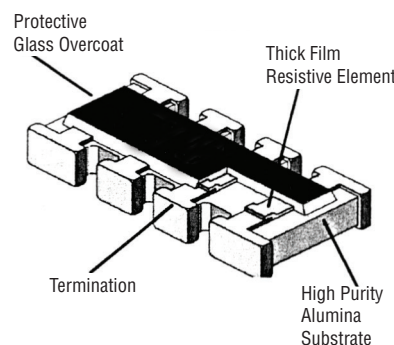

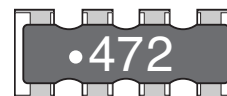

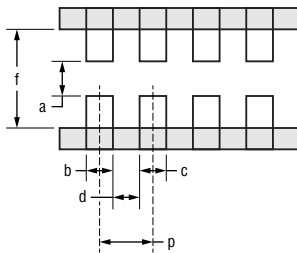
