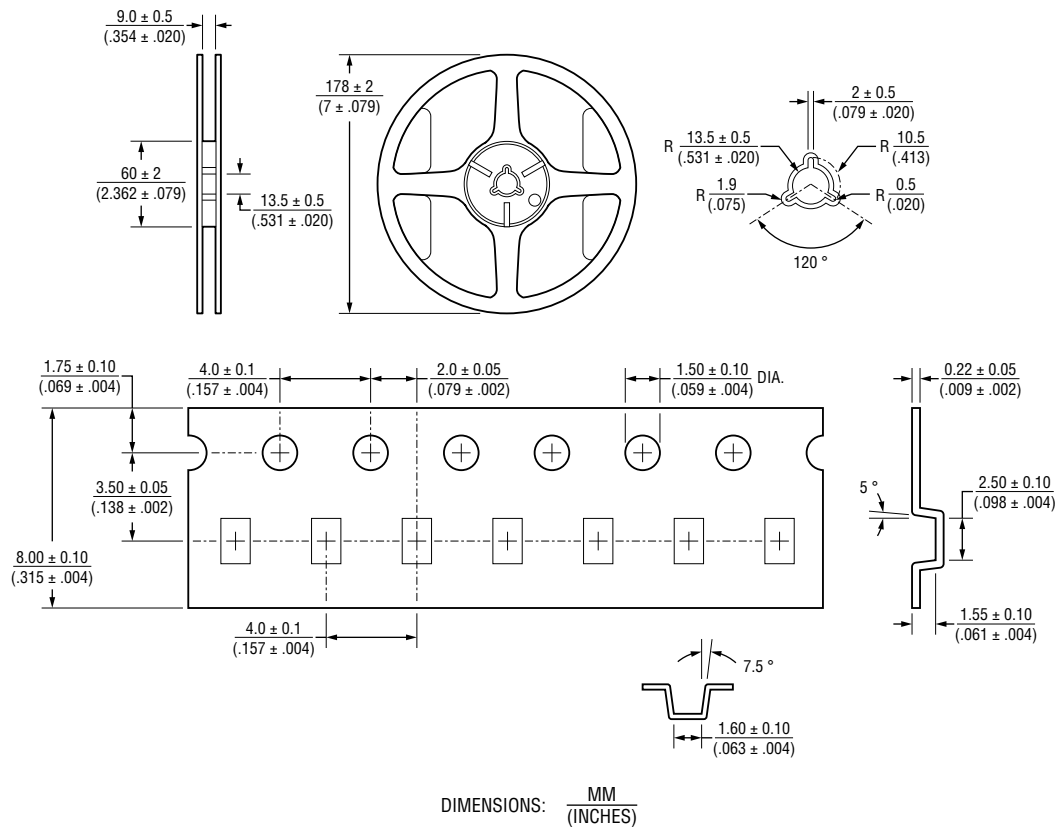
Soldering Profile
