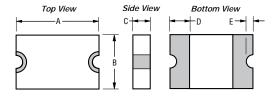

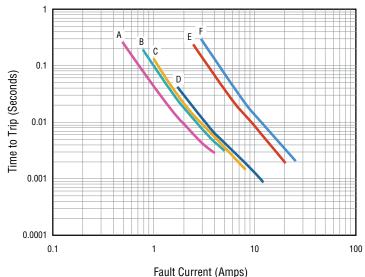

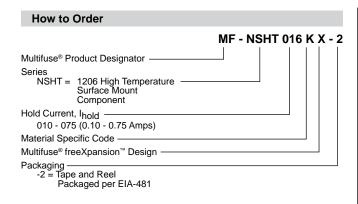

Represents total content. Layout may vary.

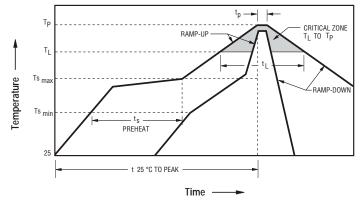

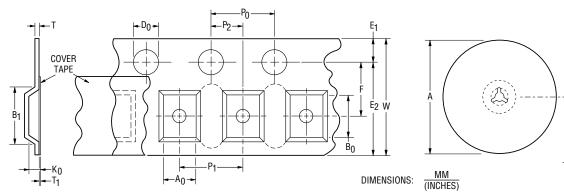

Application Notice
