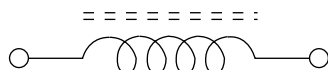

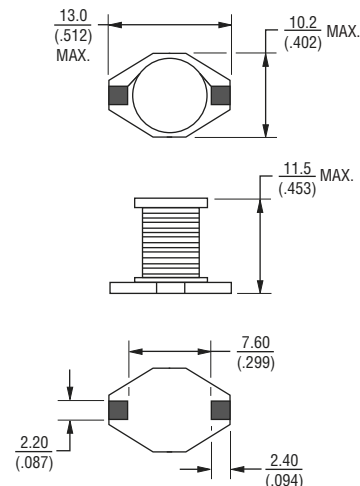

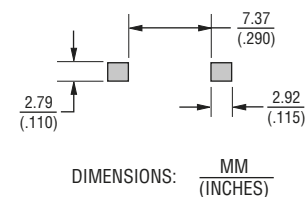

Recommended Pad Layout



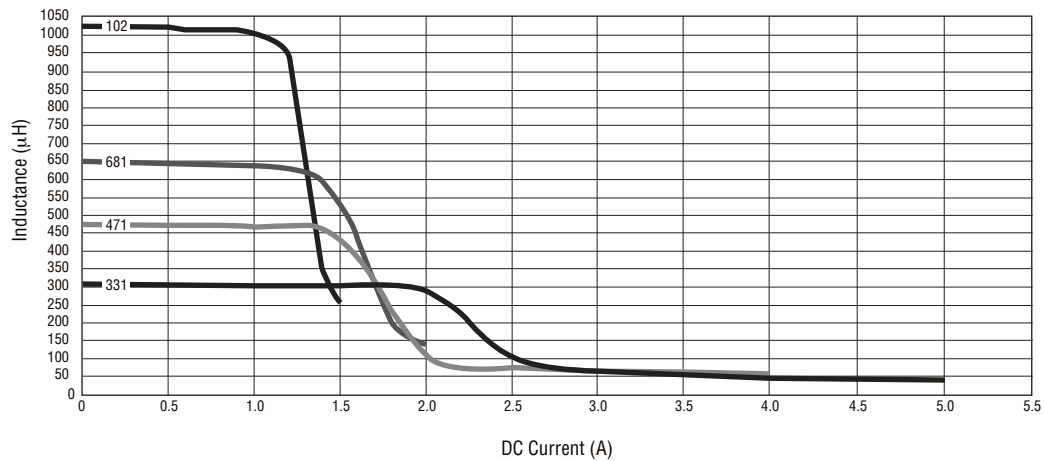
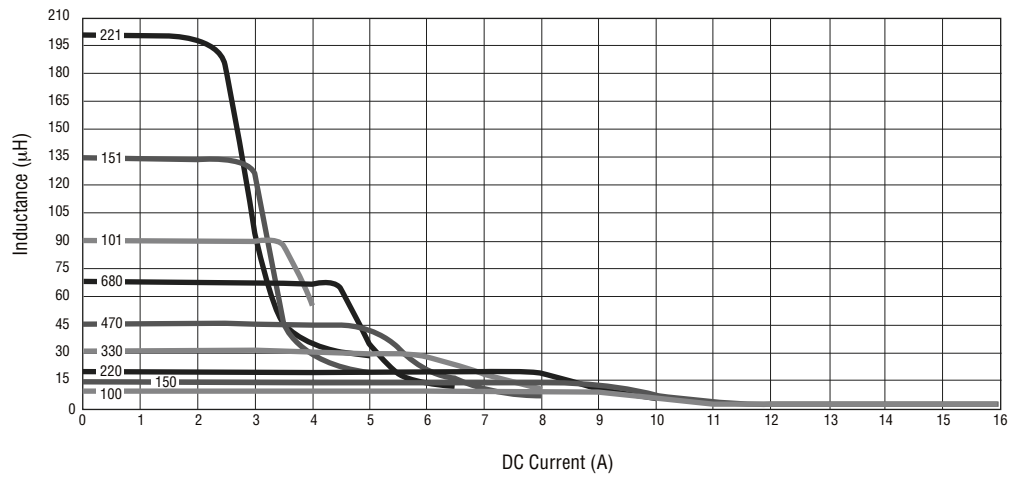

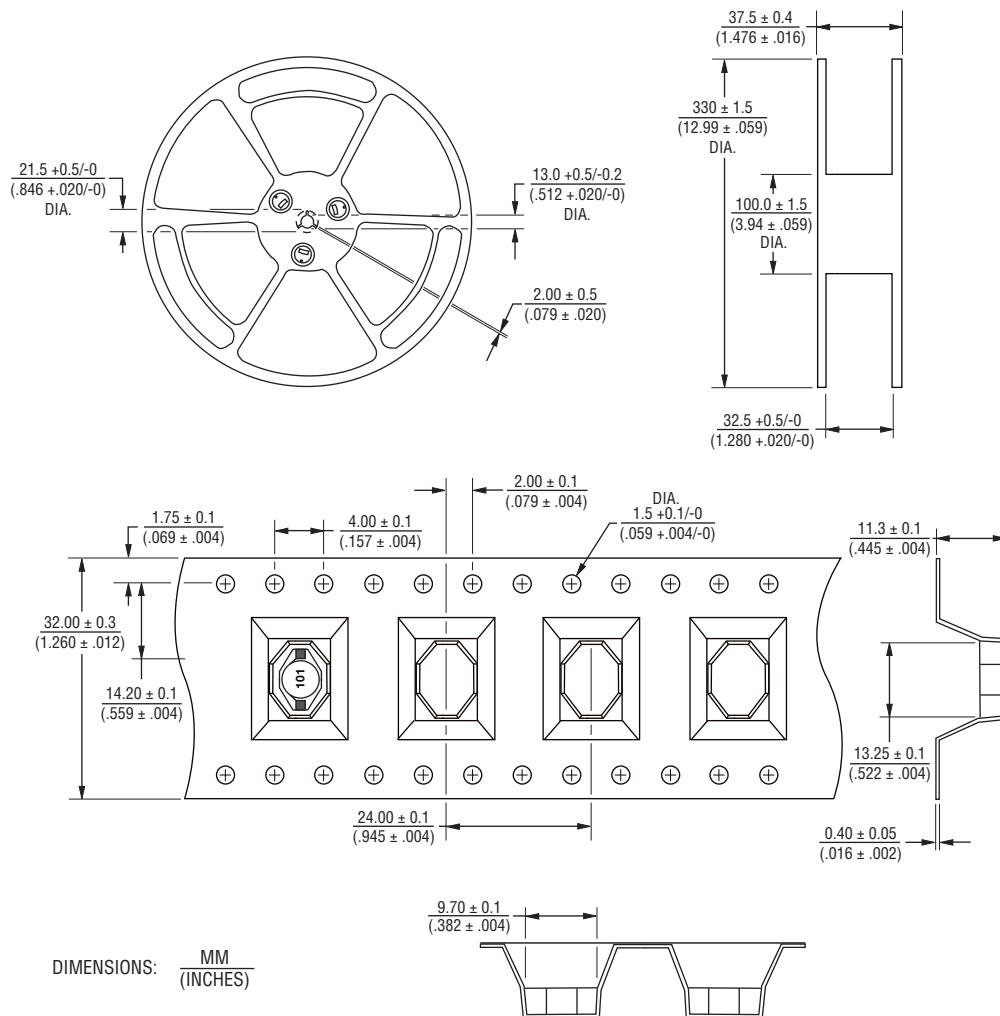
