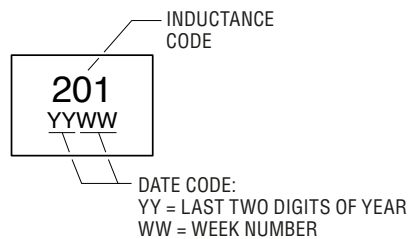
### Soldering Profile



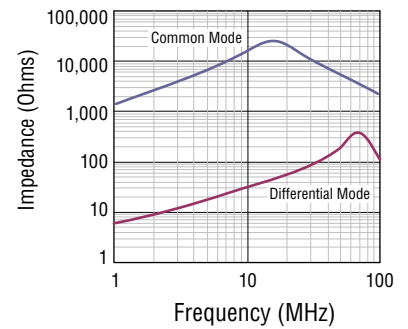
### Schematic



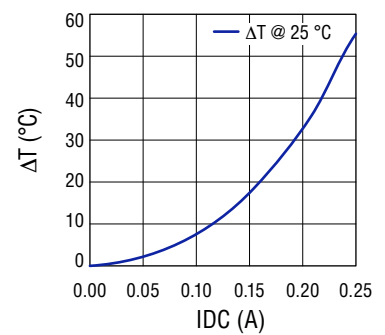
### Typical Part Marking

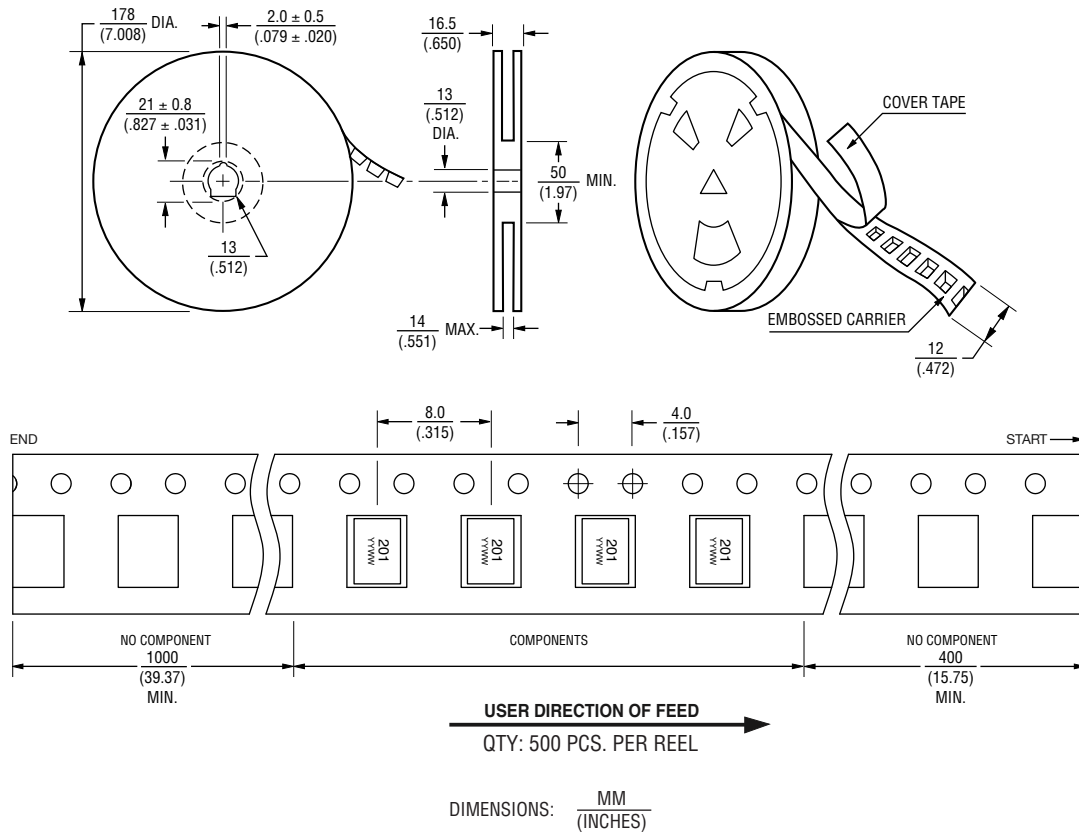
