



TISP4011H1BJ VLV Overvoltage Protector Series

General Information

The protector consists of a symmetrical voltage-triggered bidirectional thyristor. Overvoltages are initially clipped by breakdown clamping until the voltage rises to the breakover level, which causes the device to crowbar into a low-voltage on-state condition. This lowvoltage on-state causes the current resulting from the overvoltage to be safely diverted through the device. The device switches off when the diverted current falls below the holding current value.




Figure 1. Voltage-Current Characteristic for T and R Terminals All Measurements are Referenced to the R Terminal
